ANNUAL CASE ACTIVITY Narrative Summary

Total filings (including transfers in) increased by 1.4% in FY 2000, from 2,418,488 in FY 1999 to 2,452,962 in FY 2000.

Criminal filings declined from 435,224 in FY 1999 to 422,647 in FY 2000, a decrease of 2.9%. Civil filings increased 1.9%, from 240,599 in FY 1999 to 245,133 in FY 2000. Traffic filings (applicable only in justice and municipal courts) increased by 2.2%, from 1,558,375 last year to 1,593,025 in FY 2000.

Total dispositions (including transfers out) decreased by 3.2% from 2,312,769 in FY 1999 to 2,238,151 in FY 2000.

Order of protection petitions rose 2.1%, from 22,247 in FY 1999 to 22,709 in FY 2000. Emergency orders of protection were down by 6.8%, from 322 last year to 300 in FY 2000. Injunctions against harassment petitions increased 2.9%, from 16,547 in FY 1999 to 17,022 in FY 2000.

The total number of trials held in the Arizona courts decreased in FY 2000 by 3.1% from 57,730 last year to 55,962 in FY 2000. The vast majority were court trials in limited jurisdiction courts.

Adults on probation as of June 30, 2000 increased slightly by 0.3%, from 44,489 in FY 1999 to 44,643 in FY 2000. In contrast, juveniles on probation experienced a sharp increased of 8.2%, from 8,686 in FY 1999 to 9,395 in FY 2000.

There were 1,044 cases filed (including 1 reopening) in the Arizona Tax Court during FY 2000, representing a 19.0% drop from the 1,289 cases filed in FY 1999. Recent changes in Arizona's tax law are reflected in case filings. Arizona Tax Court filings are reported in Superior court other category in the statewide totals.

COURT REVENUE Statewide Narrative Summary

The statewide revenue data is provided here for each level of the Arizona courts. The first table shows the source and distribution of revenues collected by courts. The figures were compiled from probation fee reports and the quarterly revenue surveys distributed by the Supreme Court for FY 2000. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by the Arizona courts increased from \$179,348,835 in FY 1999 to \$185,971,835 in FY 2000 an increase of 3.7%.

The first table shows that the fines category accounts for \$74,125,733, or 39.9% of the total. Fees make up the second largest segment of court revenue, totaling \$67,092,603, or 36.1%. The third largest revenue category is surcharges, with \$43,849,112, or 23.6% of the total revenue.

The second table shows that FY2000 court revenue, as in previous years, is distributed fairly evenly between the state, counties, and municipalities (30.8%-35.4%), and that Municipal Courts generate almost half of all court revenue (\$87,080,172, or 46.8%). The third table (on the same page) shows that the Arizona courts processed \$125,305,149 in "pass-through" trust monies, of which restitution accounted for \$13,986,597 of the total. The majority collected was in other trust, which represents 62.9% of the total.

The establishment of a central support payment clearinghouse to receive, disburse and monitor support payments pursuant to title IV-D of the social security act, which started to take effect in FY 1998, has moved all child support payments from the courts to the Department of Economic Security. The courts only collected \$69,645 in FY 2000.

COURT EXPENDITURES Statewide Narrative Summary

The statewide expenditure information is provided here for each level of the Arizona courts. The first table shows court expenditures by source, fund, or other category. These data were compiled from Supreme Court financial records, program fund revertment reports, and annual expenditure surveys submitted to the Supreme Court for FY 2000. Major expenditure categories shown represent monies expended from five sources:

PRIMARY BUDGET: Expenditures of appropriated funds from the court's primary funding source, either the state (Supreme Court and Court of Appeals), the county (Superior and Justice Courts), or the city or town (Municipal Courts)-categories are kept as general as possible because line-item definitions for the state, counties, and municipalities vary widely;

STATE FUNDS: Expenditures of state program monies begun or renewed by the Arizona legislature and distributed to the courts;

FEDERAL FUNDS: Expenditures of federal program monies begun or renewed by the U.S. Congress and distributed to the courts (often via state agencies);

LOCAL FUNDS: Examples are expenditures from collections authorized by statute to reimburse all or part of the expenses of probation, automation, and other court services;

PRIVATE FUNDS: Expenditures of additional grants from other sources.

Total expenditures in the Arizona courts increased from \$421,142,297 to \$454,457,331 in FY 2000, up 7.9%. Primary budget expenditures account for 63.3% of the total. Salary and fringe benefit expenditures account for the largest portion (75.4%) of the primary budget. Outside primary budget expenditures, state funds account for the next largest group, at 29.7%.

The second table shows, as in previous years, that Arizona counties contributed almost half of the funds to operate the state's courts this year (\$227,640,658, or 50.1%). Likewise, the state again contributed approximately one-third of courts' expenditures in FY 2000 (\$155,939,003, or 34.3%). Expenditures from all five sources increased from FY 1999, and again, over two-thirds of these expenses were at the Superior Court level (\$306,884,799, or 67.5%).

COURT PERSONNEL Statewide Narrative Summary

The statewide summary reflects all court positions as of June 30, 2000, including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey mailed in July 2000.

The total number of persons working full-time in the Arizona judicial system increased from 7,916 in FY 1999 to 8,312 in FY 2000, a 5.0% increase.

The most notable increases in full-time personnel appear to be in the position of Detention Officer (362 to 443). The courts employed an additional 975 part-time personnel, up 11.9% from 871 in FY 1999. The largest increase in part-time personnel was also in the position of Detention Officer (134 to 169).

The courts also had the services of 1,040 regular volunteers, a decrease of 10.1% from the 1,157 in FY 1999. Volunteers include attorneys, court reporters, teachers, information desk personnel, Court Appointed Special Advocates, Foster Care Review Board members, and other professionals and non-professionals who serve as on-call magistrates.

Additionally, the courts utilized 207,997 hours of temporary personnel assistance. This is equivalent to 26,000 person-days, or almost 100 full-time employees (at 260 working days per year).

Some of the FY 1999 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Personnel reports received from courts are checked for anomalies, but are not audited by the Supreme Court.
