**Do you need an extension?** You must contact the court that holds jurisdiction over your citation and request the extension from that court. The contact information for the jurisdictional court can be found on your copy of the citation. The Arizona Supreme Court does not grant traffic citation extensions. Only the court holding jurisdiction has the authority to grant extensions.

Violations marked "CM" on the following list are eligible ONLY with the express permission of the presiding judge of the court that holds jurisdiction over your citation.

Any additional coding to the violations below, such as a number or numbers, or "SO" or "PE" are used only for local jurisdiction tracking. The number(s) coding denotes the speed over the posted limit you were alleged to be traveling, or a <u>Sheriff Office</u>-issued citation, or <u>Photo Enforcement citation</u>. This additional coding is <u>NOT</u> used in determining eligibility for the state diversion program.
