## **SUPREME COURT Narrative Summary**

During Fiscal Year 1999 there were 1,319 cases filed in the Supreme Court, a 9.5% decrease in total filings from the 1,458 cases filed in FY 98. The categories with the largest percentage increase were Civil Appeals, which increased 66.7% from 3 in FY 98 to 5 in FY 99 and Habeas Corpus (61.3%). The categories with the largest percentage decrease were Criminal Appeals (-45.5%) and Special Action - DOC Inmates (-39.4%). Numerically, Habeas Corpus case filings showed the greatest increase, from 62 in FY 98 to 100 in FY 99. In contrast, Criminal Petitions for Review evidenced the largest numerical decline, from 584 in FY 98 to 450 in FY 99. In general, case filings either increased or decreased by at least 11.0% (with the exception of two categories, Rule 28 and All Other Cases).

In the same period, the Supreme Court disposed of 1,400 cases, an increase of 9.8% from the 1,275 cases disposed during the previous fiscal year.

The differences between filings and terminations resulted in a pending caseload decrease of 13.8%, from 572 cases on July 1, 1998 to 493 cases on June 30, 1999.

Detailed breakdowns of "State Bar Matters" and "All Other Cases" and a State Bar Activity Report follow the filings and terminations summaries.



### COURT OF APPEALS - DIVISION ONE Narrative Summary

After a 3-year rise in case filings, Division One of the Court of Appeals experienced a slight decline in case filings. In Fiscal Year 99, total filings decreased by 1.2%, from 2,704 in FY 98 to 2,672. Habeas Corpus and Tax categories showed the greatest decrease in filings, declining by 33.3% and 26.7% respectively from the previous fiscal year.

Total case dispositions also decreased, from 2,566 in FY 98 to 2,457 in FY 99, a 4.2% decline.

The total pending caseload figure increased from 2,056 on July 1, 1998 to 2,274 on June 30, 1999, an increase of 10.6%.

A new civil case filing category was added this year called Civil-Settlement. This category tracks the division-reported number of Settlement Conferences filed and disposed pursuant to Rule 30 of the Arizona Rules of Court, Rules of Civil Appellate Procedure.



## COURT OF APPEALS - DIVISION TWO Narrative Summary

Following the overall trend in the appellate courts, Division Two of the Court of Appeals experienced a slight decline in case filings. In Fiscal Year 99, total filings decreased by 3.2%, from 1,157 in FY 98 to 1,120. The most notable declines were in Civil, Post Conviction Relief and Habeas Corpus filings which decreased by 38.4%, 26.3% and 42.9% respectively from the previous year.

Dispositions also decreased 6.4%, from 1,224 in FY 98 to 1,146 in FY 99. Most of this decrease was in the Criminal category.

The total pending caseload figure increased from 1,212 on July 1, 1998 to 1,265 on June 30, 1999, an increase of 4.4%.

A new civil case filing category was added this year called Civil-Settlement. This category tracks the number of division-reported Settlement Conferences filed and disposed pursuant to Rule 30 of the Arizona Rules of Civil Appellate Procedure.


