MUNICIPAL COURTS Narrative Summary

After a five year rise in filings beginning in FY1995, Municipal Courts showed a decrease in filings for the second straight year. Total filings (including transfers in) dropped from 1,420,683 in FY 2000 to 1,394,866 in FY 2001, a decrease of 1.8%.

Traffic filings (criminal and civil), which comprise 73.1% of Municipal Court case activity, dropped 2.9% from last year, from 1,049,867 to 1,019,574. Within the traffic category, both criminal filings and civil filings decreased from FY 2000 to FY 2001. Misdemeanors (excluding criminal traffic) rose from 212,518 to 224,703 in FY 2000, an increase of 5.7%.

From FY 2000 to FY 2001, Municipal Courts experienced an increase in the number of petitions filed for injunctions against harassment and orders of protection. During FY 2001, a total of 11,442 petitions were filed for an order of protection, compared with 10,278 last year, an increase of 11.3%. Petitions for an injunctions against harassment rose from 8,302 last year to 8,533 in FY 2001, an increase of 2.8%.

Total dispositions (including transfers out) increased from 1,283,063 last year to 1,386,990 in FY 2001, an increase of 8.1%. Total traffic dispositions (criminal and civil) increased by 5.7% from 957,956 in FY 2000 to 1,012,392 in FY 2001. Misdemeanor dispositions increased sharply by 13.2%, from 195,979 in FY 2000 to 221,885 in FY 2001.

Non-criminal local ordinance case filings decreased by 4.9% from 158,298 in FY 2000 to 150,589 in FY 2001. Non-criminal local ordinances terminations showed a dramatic increase of 18.3%, from 129,128 in FY 2000 to 152,713 in FY 2001.

Finally, the total end of year pending increased slightly from 871,229 in FY 2000 to 874,261 in FY 2001, an increase of 0.34%. The largest increase was reported in civil traffic which increased from 246,379 in FY 2000 to 289,225 in FY 2001, an increase of 17.4%.

Some of the FY 2000 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.





ANNUAL CASE ACTIVITY, FY 1996-2001 CASES FILED AND DISPOSED




