### MUNICIPAL COURTS Narrative Summary

After a five year rise in filings beginning in FY1995, Municipal Courts showed a decrease in filings for the second straight year. Total filings (including transfers in) dropped from 1,394,866 in FY 2001 to 1,360,306 in FY 2002, a decrease of 2.5%.

Traffic filings (criminal and civil), which comprise 74.1% of Municipal Court case activity, dropped 1.2% from last year, from 1,019,574 to 1,007,485. Within the traffic category, criminal filings increased by 8.0% and civil filings decreased by 2.7% from FY 2001 to FY 2002. Misdemeanors (excluding criminal traffic) dropped from 224,703 to 219,166 in FY 2001, a decrease of 2.5%.

From FY 2001 to FY 2002, Municipal Courts experienced an increase in the number of petitions filed for injunctions against harassment and orders of protection. During FY 2002, a total of 13,330 petitions were filed for an order of protection, compared with 11,442 last year, an increase of 16.5%. Petitions for an injunctions against harassment rose from 8,533 last year to 9,629 in FY 2002, an increase of 12.8%.

Total dispositions (including transfers out) increased from 1,386,990 last year to 1,390,604 in FY 2002, an increase of 0.3%. Total traffic dispositions (criminal and civil) increased by 3.1% from 1,012,392 in FY 2001 to 1,044,266 in FY 2002. Misdemeanor dispositions decreased sharply by 6.2%, from 221,885 in FY 2001 to 208,180 in FY 2002.

Non-criminal local ordinance case filings decreased by 11.2% from 150,589 in FY 2001 to 133,655 in FY 2002. Non-criminal local ordinances terminations showed a decrease of 19.5%, from 152,713 in FY 2001 to 138,158 in FY 2002.

Finally, the total end of year pending decreased slightly from 874,261 in FY 2001 to 851,164 in FY 2002, a decrease of 2.6%. The largest decrease was reported in civil traffic which decreased from 289,225 in FY 2001 to 252,918 in FY 2002, a decrease of 12.6%.





### ANNUAL CASE ACTIVITY, FY 1997 – 2002 CASES FILED AND DISPOSED




