Since the opening of my case, Judge \_\_\_\_\_ has shown obvious prejudice towards me, and clearly, the circumstances of my criminal charge! I have not been convicted, AS I AM

Currently "Pre-Trial", Judge has stated several times "Are you not charged with a death penalty case?" "Are you not looking at the death penalty?" I feel that she should not predict the outcome of my criminal trial. I have spent years in an abusive marriage and unfortunately, it all came to a tragic end. Prior to my charges, I was a good mother and housewife. I still can't believe this has all taken place, however, I remain strong for my children. CPS Court already has me "convicted", and Judge has only encouraged the alienation between me and my children - and will only encourage "termination of parental rights".

To date, I have received no visitation with my daughter and no approved correspondence - I have not heard from my CPS worker, AND quite honestly, Judge could care less. I know that I do have rights, BUT - my judge is not enforcing any of these rights.

I have decided to file an official Arizona State Bar complaint against Judge before I official notify the "Inspector General's Office".
