

Revised 1/9/2009-CDL (COMMERCIAL DRIVERS LICENSE) HOLDERS **ARE NOT ELIGIBLE** FOR DEFENSIVE DRIVING DIVERSION PROGRAM. This includes violations received while driving personal and commercial vehicles. PER A.R.S. 28-3392(c)(2).

Do you need an extension? Some courts allow schools to give extensions on their behalf. You must contact the court for an extension. The contact information for the jurisdictional court can be found on your copy of the citation. The Arizona Supreme Court does not grant traffic citation extensions.

Violations marked “**CM**” on the following list are eligible **ONLY** with the express permission of the presiding judge of the court that holds jurisdiction over your citation.

Any additional coding to the violations below, such as a number or numbers, or “**SO**” or “**PE**” are used only for local jurisdiction tracking. The number(s) coding denotes the speed over the posted limit you were alleged to be traveling, or a **Sheriff Office**-issued citation, or **Photo Enforcement** citation. This additional coding is **NOT** used in determining eligibility for the state diversion program.
