

## ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive) Case Activity**, the second covers **Standard Adult Probation** alone, and the third only **Intensive Adult Probation**. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second table concerns **Probationers with Petitions to Revoke**, and the third table summarizes **Additional Probation Activity**.

There were a total of 37,617 individuals added to the active **standard and intensive probation** population and 13,462 added to the absconder population during FY 2005. As of the end of FY 2005, there were 37,230 active standard and intensive probationers and 13,154 absconders in Arizona, a total of 50,384 individuals. A total of 9,541 petitions to revoke were filed during the fiscal year, and 9,010 absconders were apprehended and brought back before the court. Of all the probation violation matters brought back before the court in FY 2005, dispositions were achieved in 18,109 cases and there were 2,944 petitions to revoke pending at the end of the fiscal year. Additionally, probationers completed 1,558,774 community service hours in FY 2005 (9.1% more than FY 2004) and probation officers completed 32,350 presentence reports (down 0.1% over FY 2004). Standard and intensive probationers paid \$39,225,602 in restitution, reimbursement, fines, surcharges and fees (6.7% increase over FY 2004) and intensive probationers paid \$2,493,621 in state and federal income taxes.

There were 32,066 individuals added to the active **standard** probation population and 12,129 added to the standard absconder population in FY 2005. During the fiscal year, 31,717 individuals were terminated from standard probation and 10,922 absconder warrants were closed. On June 30, 2005, there were 34,229 active standard probationers and 12,290 standard probation absconders. A total of 7,699 petitions to revoke were filed on standard probationers during FY 2005, and 8,024 absconders were apprehended and brought back before the court. Of all the standard probation violation matters brought back before the court, dispositions were achieved in 15,311 cases, leaving 2,513 petitions to revoke pending at the end of the fiscal year. Standard probationers completed 828,201 community service hours and paid a total of \$36,459,324 in court ordered penalties.

During FY 2005, 5,551 individuals were added to the active **intensive** probation population and 1,333 added to the intensive absconder population. Over the course of the fiscal year, 5,473 individuals were terminated from intensive probation and 1,513 absconder warrants were closed. At the close of the fiscal year there were 3,001 active intensive probationers and 864 intensive probation absconders. A total of 1,842 petitions to revoke were filed on intensive probationers during FY 2005 and 986 absconders were apprehended and brought back before the court. Of all the intensive probation violation matters brought back before the court, 2,798 reached disposition, leaving 431 intensive petitions to revoke pending at the end of the fiscal year. Intensive probationers completed 730,573 hours of community service and paid \$5,259,899 in fines, restitution and other monies.
