Appellate and Superior Court Narrative Summary

This summary shows all appellate court, superior court and adult/juvenile probation positions as of June 30, 2006, including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey distributed in August 2006.

The total number of persons working full-time in the Supreme Court decreased from 431 in FY 2005 to 412 in FY 2006. Most of the full-time employees in the Supreme Court work for the Administrative Office of the Courts (372 of the 412). Full-time employees in the Court of Appeals (both divisions) increased by five positions, from 135 in FY 2005 to 140 in FY 2006. Full-time employees in Superior Court (including the clerk's office) increased from 2,901 to 3,261 this fiscal year, an increase of 12.4%. Superior Court Probation (comprising adult, juvenile, and combined departments) full-time employees increased from 3,923 in FY 2005 to 4,096 in FY 2006, an increase of 4.4%.

The Supreme Court had the services of 1,602 regular volunteers in FY 2006. The Superior Court had the services of 103 regular volunteers, while Superior Court Probation utilized the services of 315 regular volunteers. These people include professionals and non-professionals who serve in many different capacities.

Additionally, Superior Court utilized 54,898 hours of temporary personnel assistance, and the Superior Court Probation utilized 29,225 hours of temporary personnel assistance.

Some of the FY 2005 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.
