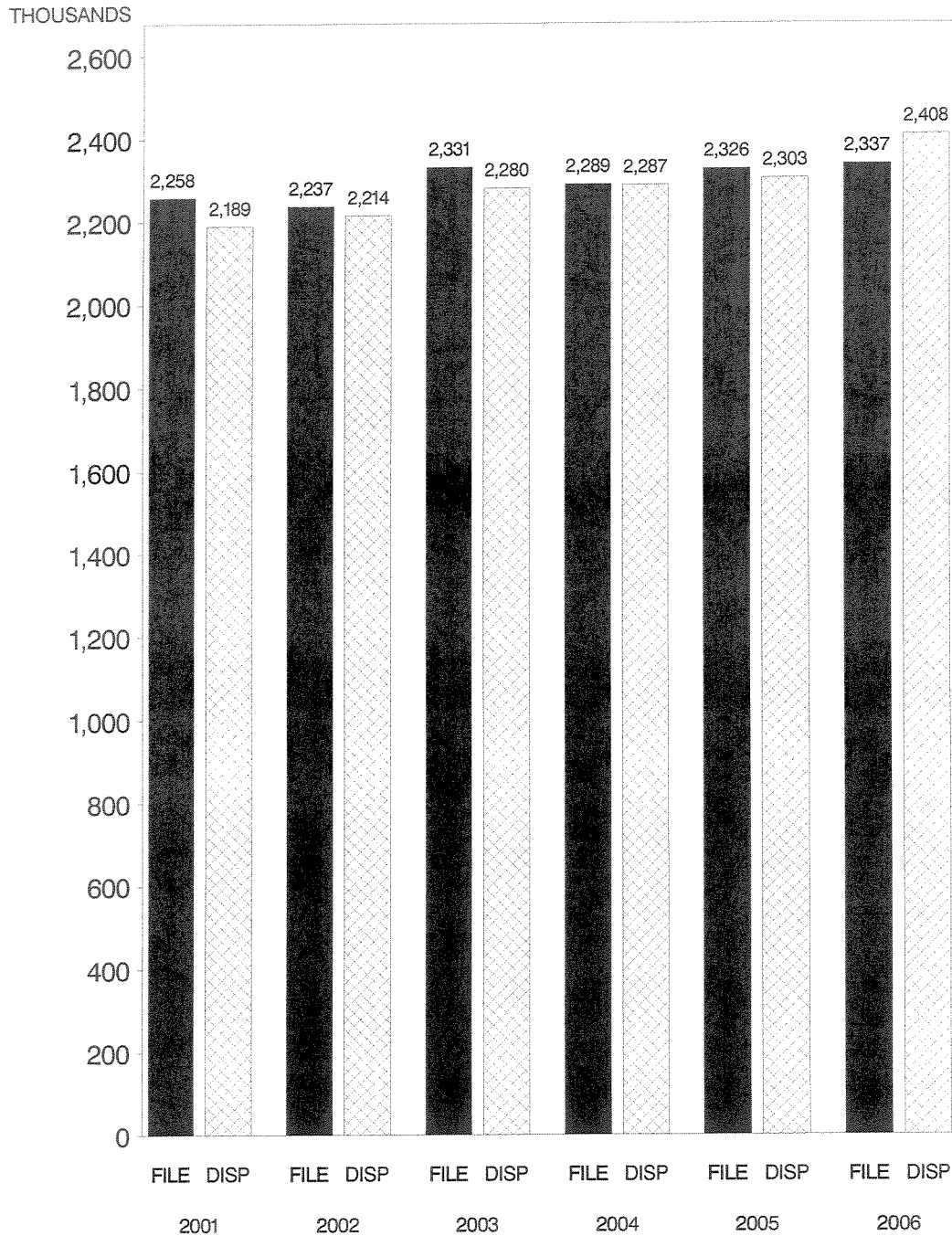

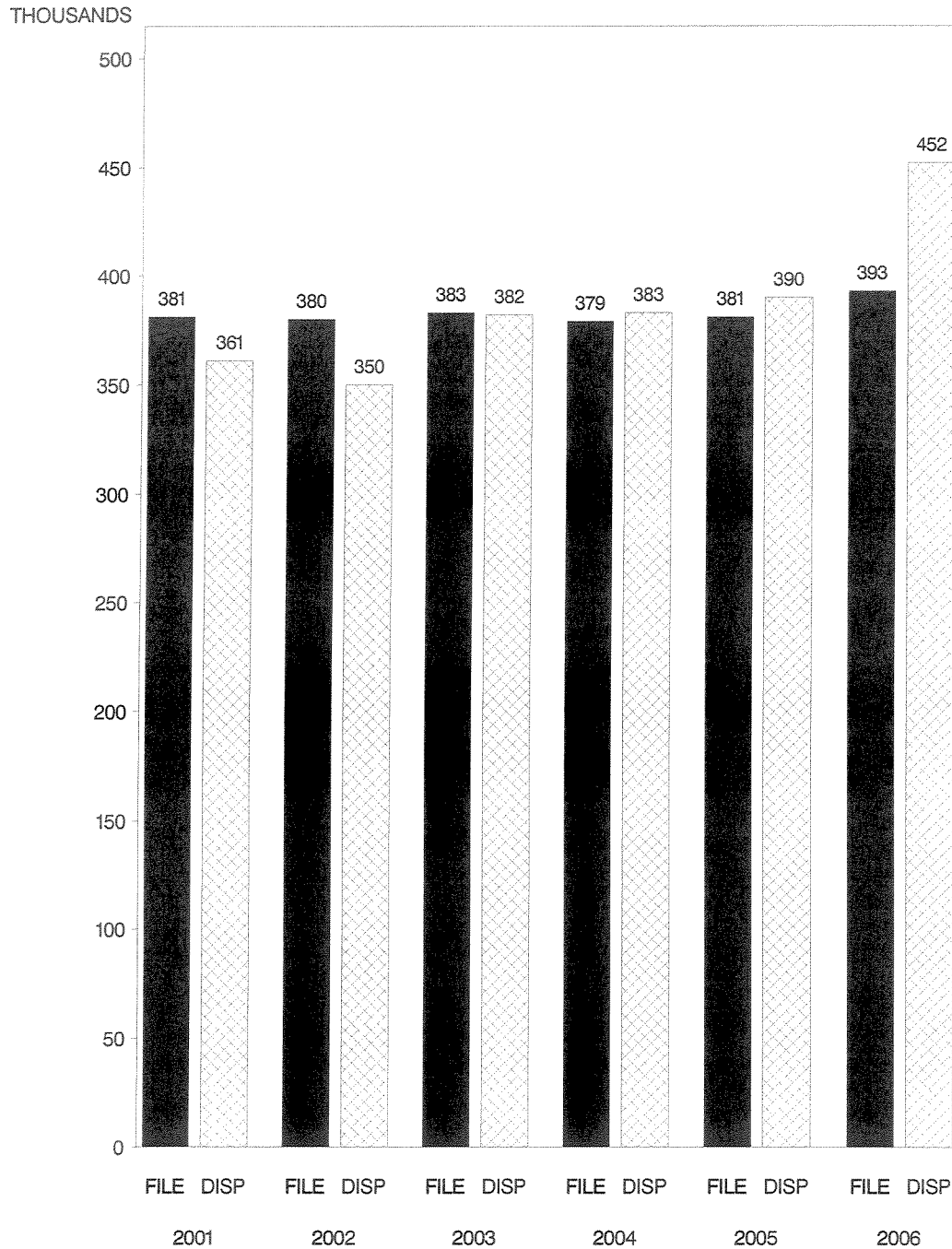

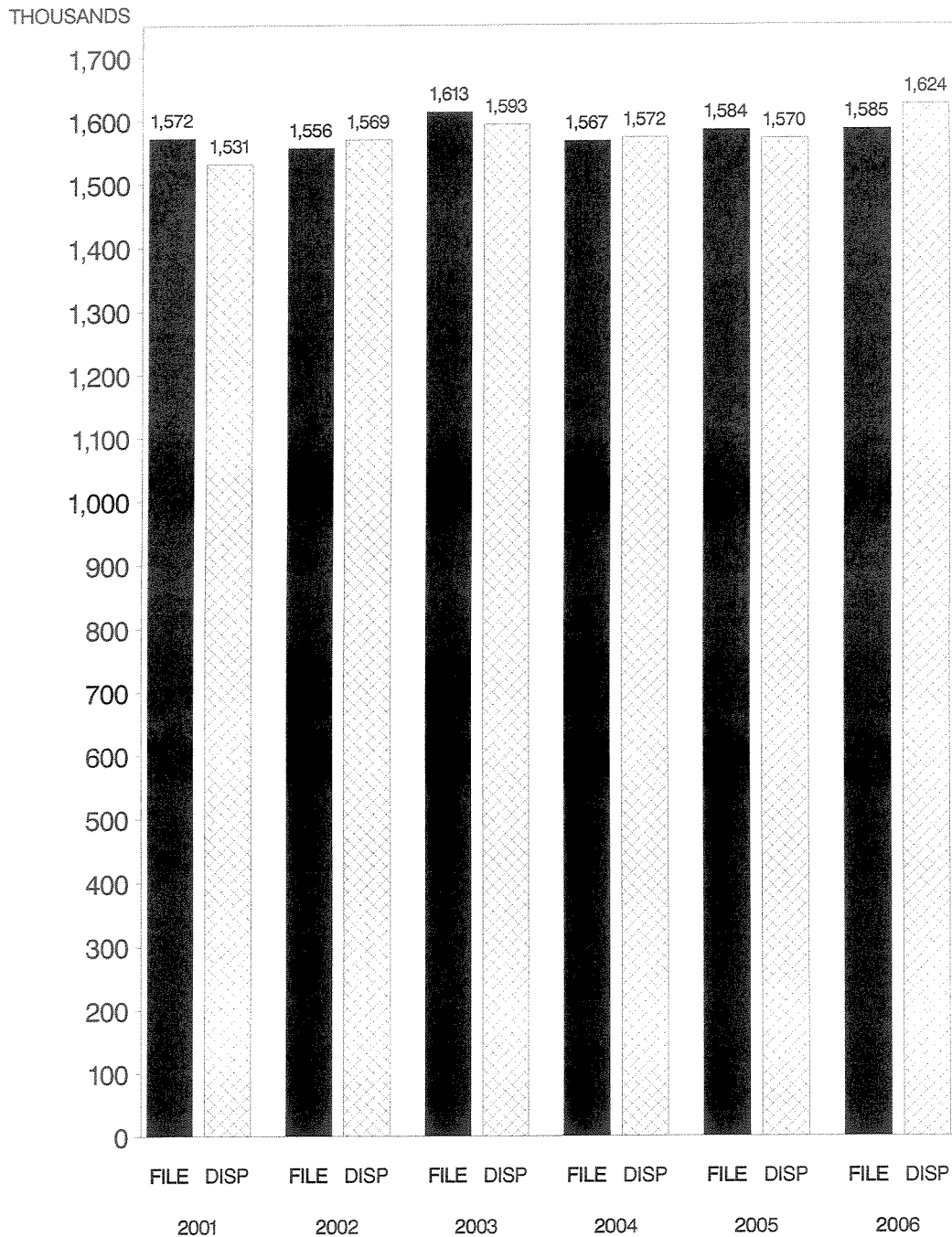

COMBINED TRAFFIC CASE ACTIVITY, FY 2001 – 2006

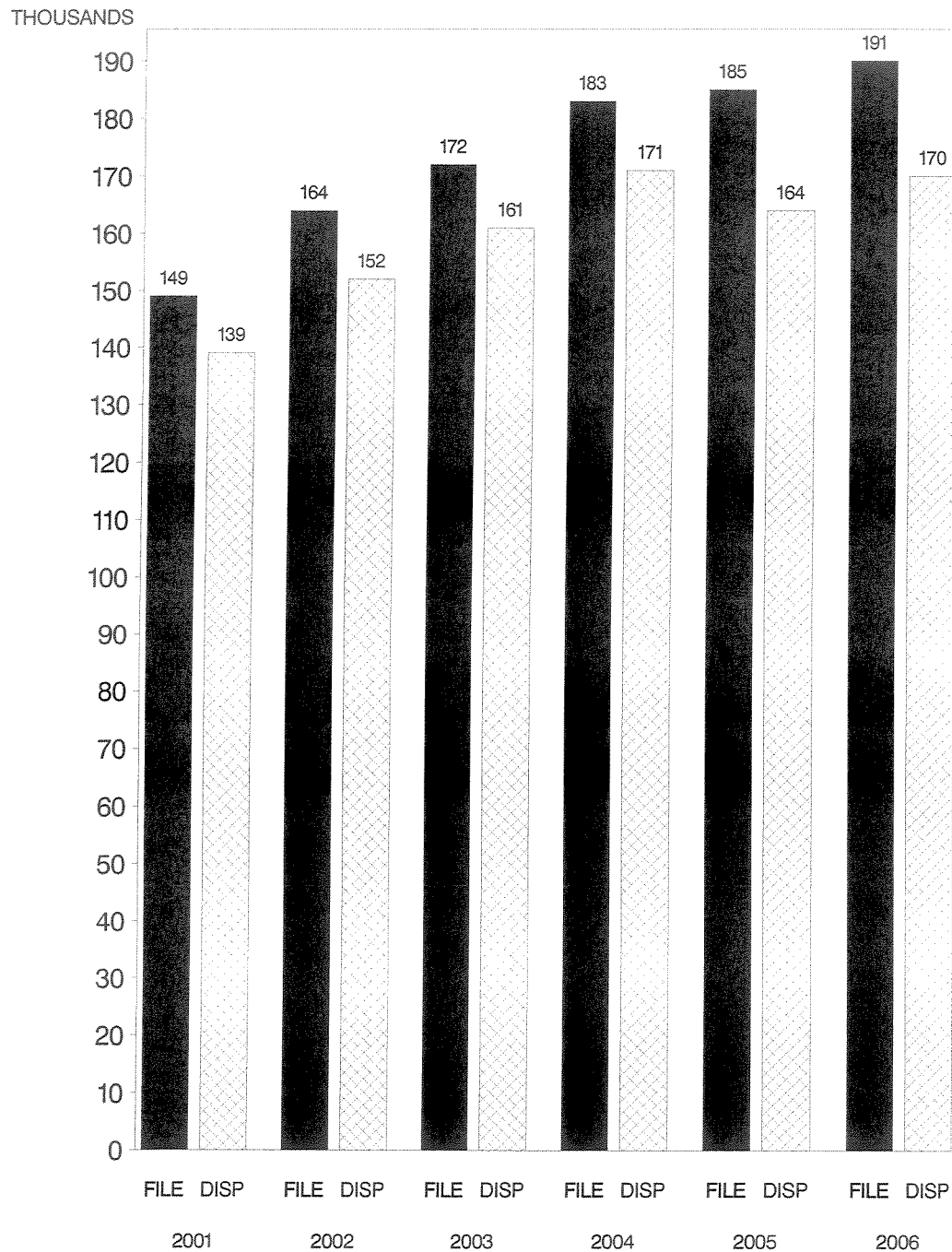
