Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2007 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in August and September 2007.

The total number of persons working full-time in the Limited Jurisdiction Courts increased by 6.6%, from 1,762 in FY 2006 to 1,878 in FY 2007. In FY 2007, there were 726 people employed full-time in the Justice Courts, compared with 693 the previous year. Full-time employees in the Municipal Courts increased from 1,069 last fiscal year to 1,152 in FY 2007.

The Limited Jurisdiction Courts employed an additional 533 part-time personnel in FY 2007, compared to 429 in FY 2006, an increase of 24.2%. The Justice Courts employed 139 part-time personnel, versus 125 the previous fiscal year. The Municipal Courts employed 394 part-time personnel, compared to 304 in FY 2006.

The courts also had the services of 44 regular volunteers in FY 2007. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 20 regular volunteers while the Municipal Courts had the services of 24.

Additionally, the Limited Jurisdiction Courts utilized 27,838 hours of temporary personnel assistance in FY 2007. The Justice Courts used 12,909 hours of temporary personnel, while the Municipal Courts had 14,929 hours.

Some of the FY 2006 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
