

COURT REVENUE

Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from quarterly revenue surveys submitted to the Supreme Court during fiscal year 2007. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by Limited Jurisdiction Courts increased from \$241,627,634 in FY 2006 to \$268,815,956 in FY 2007, an increase of 11.3%. Justice Court revenue increased from \$81,245,952 last year to \$87,605,023 in FY 2007, up 7.8%. Municipal Court revenue went from \$160,381,682 in FY 2006 to \$181,210,933 in FY 2007, an increase of 13.0%.

The fines category is the largest at \$123,226,408, accounting for 45.8% of the total. Most of these fines (\$84,186,027, or 68.3%) were assessed in Municipal Courts. The second largest category is surcharges, accounting for \$80,038,431, or 29.8% of the total revenue. Again, the majority of the surcharges were assessed in Municipal Courts (\$53,389,006 or 66.7%).

Maricopa and Pima County Justice Courts comprise 52.9% of all Justice Court revenue. Municipal Courts from these two counties constitute 86.3% of all Municipal Court revenue. The two largest Municipal Courts --Phoenix and Tucson--not only account for 36.9% of all Municipal Court revenue, but 24.9% of the revenue from all Arizona Limited Jurisdiction Courts. In all, Maricopa and Pima County Limited Jurisdiction Courts collect 75.5% of all Justice and Municipal Court revenue.

The Annual Trust Money Collection Summary shows that the Limited Jurisdiction Courts processed \$40,493,493 in "pass-through" trust monies in FY 2007, most of which (88.0%) were for bail bonds.
