The Presiding Disciplinary Judge accepted the parties' Agreement for Discipline by Consent pursuant to Rule 57(a), Ariz. R. Sup. Ct.,

Accordingly:

IT IS ORDERED Respondent, **DAVID ALAN. DICK, Bar No. 013518**, is suspended for sixty (60) days for his conduct in violation of the Arizona Rules of Professional Conduct, as outlined in the consent documents, effective **May 29, 2020 through July 27, 2020**.

IT IS FURTHER ORDERED that during his term of suspension and in addition to his regular yearly MCLE requirements, Mr. Dick shall complete the following Continuing Legal Education program: "Common Courtroom Conundrums: Candor, Courtesy, and Confidences." He shall provide the State Bar

Compliance Monitor with evidence of completion of the program by providing a copy of handwritten notes. Mr. Dick shall contact the Compliance Monitor at (602) 340-7258 to arrange to submit this evidence. Mr. Dick is responsible for the cost of the CLE.

IT IS FURTHER ORDERED Respondent shall pay restitution to Julie Carter in the amount of \$1,000.00 within thirty (30) days from the date of this Order. Respondent shall contact the State Bar Compliance Monitor at (602) 340-7258 to provide proof of timely payment of restitution.

IT IS FURTHER ORDERED Respondent shall not be reinstated unless and until he complies with the foregoing CLE and restitution requirements.

IT IS FURTHER ORDERED pursuant to Rule 72 Ariz. R. Sup. Ct., Respondent shall timely comply with the requirements relating to notification of clients and others.

IT IS FURTHER ORDERED Mr. Dick shall pay the costs and expenses of the State Bar of Arizona in the amount of \$ 1,200.00, within thirty (30) days of this Order. There are no costs or expenses incurred by the Office of the Presiding Disciplinary Judge in these proceedings.
