Having considered Applicant, **JAMES ROGER WOOD'S**, Affidavit in Support of Reinstatement filed February 12, 2016, pursuant to Rule 64(e)(2), Ariz. R. Sup. Ct., and there being no objection by the State Bar; Accordingly:

IT IS ORDERED Applicant, **JAMES ROGER WOOD**, be reinstated to the active practice of law in Arizona effective the date of this order.

IT IS FURTHER ORDERED JAMES ROGER WOOD is placed on probation for a period of one (1) year effective the date of this order under the following terms and conditions:

Terms and Conditions of Probation

1. Mr. Wood shall participate in the State Bar's Law Office Management Assistance Program (LOMAP). Mr. Wood shall contact the State Bar's Compliance Monitor within 10 days from the date of this order.
2. Mr. Wood shall submit to a LOMAP examination of his office procedures. Mr. Wood shall sign terms and conditions of participation, including reporting requirements, which shall be incorporated. The period of probation is effective the date of this order and shall conclude one year from that date.

3. The State Bar shall report material violations of the terms of probation pursuant to Rule 60(a)(5), Ariz. R. Sup. Ct., and a hearing may be held within thirty (30) days to determine if the terms of probation have been violated and if an additional sanction should be imposed. The burden of proof shall be on the State Bar to prove non-compliance by a preponderance of the evidence.
