The Court will grant the motion for warrant of execution at the end of fourteen days unless, within that period, Eric King files a Rule 32 notice of post-conviction relief in the superior court challenging the constitutionality of Arizona's lethal injection protocol similar to the claim raised in pending post-conviction relief proceedings in State v. Landrigan, Maricopa County Superior Court case number CR1990-000066. If Mr. King files such a Rule 32 notice, he shall provide proof of same to this Court and to the State's counsel no later than May 5, 2009.
