ADMINISTRATIVE
DIRECTIVE

Pursuant to A.R.S. §14-5651 and Arizona Supreme Court Administrative Order No. 2002-102 and as further provided in the Administrative Rules governing fiduciaries in Arizona, specifically Rule 1.2.6, the Director of the Administrative Office of the Courts ("AOC") makes the following findings of fact, conclusions of law, decision and order.

BACKGROUND FACTS

On April 29, 2003, the AOC received a request for disclosure of confidential information regarding complaint number 02-0034, from the Law Office of Douglas C. Fitzpatrick ("Fitzpatrick"). Fitzpatrick is the court appointed attorney for Myrtle Van Campen ("Van Campen"). Linda Carol Hogan ("Hogan") is a certified fiduciary who is the court appointed guardian and conservator for Van Campen. Fitzpatrick is requesting a copy of Hogan's response to the AOC, regarding complaint number 02-0034, in preparation for a settlement conference regarding Hogan's request for approval of her fifth annual accounting and the subsequent objections filed by Fitzpatrick.

FINDINGS OF FACT

The Director of Administrative Office of the Courts finds as follows:

1. Disclosure of confidential information regarding complaint number 02-0034 against Hogan, is in the best interest of the public and such interest is not outweighed by any other interest or is not contrary to law. The disclosure is limited to the purpose stated below.

1 **FINAL DECISION AND ORDER OF THE DIRECTOR**

2 IT IS ORDERED the confidential complaint information, relating to the complaint #02-0034,
3 filed against Hogan, specifically Hogan's response to the program, be disclosed to Fitzpatrick,
4 pursuant to his written request dated April 28, 2003. This disclosure is for the purposes of
5 administration of probate matters regarding Fitzpatrick's client and Hogan, specifically a settlement
6 conference scheduled for May 14, 2003, before the Honorable David Mackey in the Superior Court
7 of Yavapai County.
