Administrative Order  
No. 2010 - 136

The Arizona Supreme Court has approved amendments to the Rules of the Supreme Court governing the attorney discipline system. The revised rules take effect on January 1, 2011. Pursuant to Rule 52, as revised, hearing panels are established for the purpose of holding a hearing on the merits of a contested formal complaint, an application for reinstatement to the practice of law and any other matters designated by the court.

Each hearing panel will consist of the Presiding Disciplinary Judge, a volunteer attorney member, and a volunteer public member. The chief justice shall appoint the Presiding Disciplinary Judge to the hearing panels by virtue of the position; he shall serve in that capacity while employed as the presiding disciplinary judge. The chief justice shall also appoint a pool of volunteer attorney and public members to serve on the hearing panels. Initially, the volunteer members are appointed for fixed, staggered terms of one (1) or two (2) years.

Appointment of members of the hearing panels is necessary prior to the effective date of the revised rules. Additional appointments of members for hearing panels may be made at a later date. Therefore,

IT IS ORDERED appointing members of the Attorney Discipline hearing panels for terms as set out in Appendix "A."

IT IS FURTHER ORDERED that appointed volunteer attorney members may also serve as settlement officers, pursuant to Rule 52(b), as revised.
