On August 28, 2018, this Court adopted a new Rule 42.1(a) of the Arizona Rules of the Supreme Court effective January 1, 2019. Rule 42.1 establishes the attorney ethics advisory committee, its powers and duties, scope of work, and procedures to be followed in requesting and issuing opinions. Rule 42.1(a) requires the chief justice to appoint members to the committee.

Therefore, pursuant to Rule 42.1(a) of the Arizona Rules of the Supreme Court and Article VI, Section 3 of the Arizona Constitution,

IT IS ORDERED:

1. **MEMBERSHIP:** The individuals listed in Appendix A are appointed as members of the Committee effective January 1, 2019 with membership terms as designated. The Chief Justice may appoint additional members as necessary.
2. **MEETINGS:** Committee meetings shall be scheduled at the discretion of the Chair. All meetings shall comply with the Arizona Code of Judicial Administration § 1-202: Public Meetings.
3. **STAFF:** The Supreme Court through its Administrative Office of the Courts will provide staff assistance to the Committee as appropriate.
