This matter came before the Disciplinary Commission of the Supreme Court of Arizona on May 10, 2003, pursuant to Rule 53(d), Ariz. R. S. Ct., for consideration of the Hearing Officer's Report, filed March 12, 2003, recommending disbarment, restitution, and costs.

Decision

The Commission's standard of review is set forth in Rule 53(d)2, which states that the Commission reviews questions of law *de novo*. In reviewing findings of fact made by a hearing officer, the Commission applies a clearly erroneous standard.

Therefore, having found no findings of fact clearly erroneous, the nine members of the Commission unanimously recommend adopting and incorporating by reference the Hearing Officer's findings of fact, conclusions of law, and recommendation for disbarment, restitution in the amount of \$17,900.00 plus interest at the legal rate from September 21, 2001 to be paid to John J. Schultz, and costs.



NOTICE OF OMISSION

This matter came before the Disciplinary Commission of the Supreme Court of Arizona on May 10, 2003, pursuant to Rule 53(d), Ariz. R. S. Ct., for consideration of the Hearing Officer's Report, filed March 12, 2003, recommending disbarment, restitution, and costs. The Commission filed a Report on May 27, 2003 recommending the adoption and incorporation by reference of the Hearing Officer's findings of fact, conclusions of law, and recommendation for disbarment, restitution in the amount of \$17,900.00 plus interest at the legal rate from September 21, 2001 to be paid to John J. Schultz, and costs; however, the Report omitted an additional award of restitution and contained a clerical error.

The Commission hereby gives notice to the parties and the Court of said omission. The Commission adopted the Hearing Officer's Report in its entirety for disbarment, restitution in the amount of \$17,900.00 plus interest at the legal rate from September 20, 2001 to be paid to John J. 
