17 The Commission's standard of review is set forth in Rule 53(d)2, which states that

19 hearing officer, the Commission applies a clearly erroneous standard.

20 Therefore having found no findings of fact clearly erroneous, the seven<sup>1</sup> members of  
21 the Commission unanimously recommend adopting and incorporating by reference the  
22 attached Hearing Officer's findings of fact, conclusions of law and recommendation for
