) **JUDGMENT AND ORDER**

This matter having come on for hearing before the Disciplinary Commission of the Supreme Court of Arizona, it having duly rendered its decision and no discretionary review occurring,


IT IS ORDERED, ADJUDGED AND DECREED that **WILLIAM L. KENDRICK, JR.**, a member of the State Bar of Arizona, is hereby censured for conduct in violation of his duties and obligations as a lawyer, as disclosed in the Disciplinary Commission Report.

IT IS FURTHER ORDERED that **WILLIAM L. KENDRICK, JR.** shall be placed on probation for a period of one (1) year. The terms of probation are as follows:

- 1) Respondent shall submit to a Law Office Management Assistance Program (LOMAP) audit within thirty (30) days of this order. Respondent shall enter into a Memorandum of Understanding consistent with the findings of the LOMAP director or designee.
- 2) Respondent shall refrain from any conduct that would violate the Rules of Professional Conduct or other rules of the Supreme Court of Arizona.
- 3) Respondent shall pay costs within thirty (30) days of the date of this order.
- 4) In the event Respondent fails to comply with any of the foregoing terms and information thereof is received by the State Bar, bar counsel shall file a Notice of Non-Compliance with the Disciplinary Commission. The Disciplinary Commission may refer the matter to a hearing officer to conduct a hearing at the earliest possible date, but in no event later than thirty (30) days following receipt of said notice. If the matter is referred to a hearing officer, the hearing officer shall determine whether the terms of probation have been breached, and if so, to recommend appropriate action and response to such breach.
- 5) If there is an allegation that Respondent failed to comply with any of the foregoing terms, the burden of proof shall be on the State Bar to prove non-compliance by clear and convincing evidence.

IT IS FURTHER ORDERED that pursuant to Rule 60(b), formerly Rule 52(a)8, the State Bar of Arizona is granted judgment against **WILLIAM L. KENDRICK, JR.** for costs and expenses of these proceedings in the amount of \$727.82, together with interest at the legal rate from the date of this judgment.


