This matter came before the Disciplinary Commission of the Supreme Court of Arizona on April 7, 2006, pursuant to Rule 58, Ariz. R. S. Ct., for consideration of the Hearing Officer's Report filed February 7, 2006 recommending a two year suspension, an assessment by the State Bar's Member Assistance Program (MAP), two years of probation upon reinstatement, with terms and conditions to be determined at the time of reinstatement, restitution, and costs of these disciplinary proceedings.

Decision

The eight members¹ of the Disciplinary Commission unanimously recommend accepting and adopting the Hearing Officer's findings of fact, conclusions of law, and recommendation providing for two year suspension, a MAP assessment, two years of probation upon reinstatement (with the terms and conditions to be determined at the time of reinstatement), restitution, and costs of these disciplinary proceedings.² Restitution is as follows:
