This matter originally came before the Disciplinary Commission of the Supreme Court of Arizona on May 13, 2006, pursuant to Rule 58, Ariz. R S. Ct., for consideration of the Hearing Officer's Report filed March 10, 2006, recommending disbarment, restitution and costs of these disciplinary proceedings.

**Decision**

The seven members<sup>1</sup> of the Disciplinary Commission unanimously adopt the Hearing Officer's findings of fact, conclusions of law, and recommendation of disbarment, restitution, and costs of these disciplinary proceedings.<sup>2</sup> The Commission further recommends that the State Bar refer this matter to the Maricopa County Attorney's Office for possible prosecution. Restitution is as follows:

**Restitution**

To the Estate of Rita J. Corron: \$21,231.95 plus interest at statutory rate from date of entry of judgment.
