19 This matter first came before the Disciplinary Commission of the Supreme Court of
20 Arizona on March 10, 2007, pursuant to Rule 58, Ariz. R. Sup. Ct., for consideration of the
21 Hearing Officer's Report filed January 23, 2007, recommending a six-month and one-day
22 suspension, two years of probation upon reinstatement with the State Bar's Law Office
23 Management Assistance Program (LOMAP), Trust Account Ethics Enhancement Program
24 (TAEEP), and costs. The Respondent filed a Request to File Brief on March 9, 2007. The
25 Commission granted the request in part. The Commission continued the matter and
26 ordered the Respondent to file her brief before March 23, 2007. *See* Commission Order
filed March 12, 2007. Respondent thereafter, failed to file her brief.

Decision

The nine members¹ of the Disciplinary Commission unanimously recommend accepting and adopting the Hearing Officer's findings of fact, conclusions of law, and recommendation for a six-month and one-day suspension, two years of probation upon

1 reinstatement (LOMAP and TAEEP) and costs of these disciplinary proceedings.² The
2 specific terms and conditions of probation shall be determined upon reinstatement.


