9 This matter came before the Disciplinary Commission of the Supreme Court of
10 Arizona on June 14, 2008, pursuant to Rule 58, Ariz R Sup Ct , for consideration of the
11 Hearing Officer's Report filed May 2, 2008, recommending acceptance of the Tender of
12 Admissions and Agreement for Discipline by Consent and Joint Memorandum providing
13 for censure, one year of probation (complete course entitled "Ten Deadly Sins of
14 Conflict") and payment of costs within 30-days of the date of the final Judgment and



18 Having found no facts clearly erroneous, the eight members¹ of the Disciplinary
19 Commission unanimously recommend accepting and incorporating the Hearing Officer's
20 findings of fact, conclusions of law, and recommendation for censure, one year of
21 probation, the only term being that Respondent shall complete the course entitled "Ten
22 Deadly Sins of Conflict," and costs of these disciplinary proceedings with 30-days of the


