

COURT OF APPEALS - DIVISION TWO
Narrative Summary

Division Two of the Court of Appeals experienced a decrease in case filings. In fiscal year 2006, total filings decreased by 1.1%, from 901 in FY 2005 to 891. The most notable decrease was in Post Conviction Relief filings which decreased by 8.6%, from 175 filings in FY 2005 to 160 in FY 2006. The other category that showed a significant decrease in filings was the Sexually Violent Predator case category which decreased from 4 in FY 2005 to 1 in FY 2006, or 75.0%. Juvenile case filings decreased from the previous fiscal year by 5.5%, from 93 in FY 2005 to 88 in FY 2006. Civil cases reported an increase of 8.1%, from 173 in FY2005 to 187 in FY2006.

Dispositions showed a large decrease of 26.8%, from 1,218 in FY 2005 to 891 in FY 2006. Most of the decrease was in the "Criminal" and "Post Conviction Relief" categories.

The total pending caseload figure increased from 954 on July 1, 2005 to 1,007 on June 30, 2006 an increase of 5.6%.

A new mental health case filing category was added in fiscal year 2000, called Mental Health (MH) Sexual Predator. This category tracks the division-reported number of sexual predator cases filed. Division One began breaking out sexual predator cases from the mental health case category in fiscal year 2003, while Division Two began reporting sexual predator cases separately from mental health cases in fiscal year 2000.


