LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 3.5% in FY 2009, from 2,582,222 last year to 2,493,103. Traffic cases comprised the majority (69.9%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 4.5%, from 1,823,839 last year to 1,741,522 in FY 2009. Criminal filings (misdemeanors and felonies) decreased by 2.5%, from 383,640 in FY 2008 to 374,136 in FY 2009.

Petitions for orders of protection in domestic violence cases increased from 21,960 in FY 2008 to 22,173 in FY 2009, an increase of 1.0%. Petitions for injunctions against harassment decreased, from 19,372 in FY 2008 to 18,790 in FY 2009, a decrease of 3.0%.

Total dispositions (including transfers) increased by 2.1%, from 2,632,863 last year to 2,688,381 in FY 2009. Traffic dispositions (criminal and civil) decreased by 0.8% while criminal dispositions (misdemeanor and felony) increased by 10.0% from last year. Only 10.4% of the orders of protection and 14.9% of the harassment petitions ruled upon were denied.

The total pending caseload figure decreased from 1,624,795 in FY 2008 to 1,568,004 in FY 2009, a decrease of 3.4%. Most of the decrease was in the civil traffic category, which decreased from 354,275 in FY 2008 to 321,490 in FY 2009, a decrease of 9.3%. The criminal traffic category also decreased, from 273,443 in FY 2008 to 264,831 in FY 2009, which was a decrease of 3.2%.

NOTE: Some of the FY 2008 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.










