Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during fiscal year 2015. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Revenue collected from limited jurisdiction courts decreased from \$288,512,586 in FY 2014 to \$280,664,032 in FY 2015, a decrease of 2.7%. Justice court revenue decreased from \$106,649,778 last fiscal year to \$102,733,301 in FY 2015, down 3.7%. Municipal court revenue decreased from \$182,862,808 in FY 2014 to \$177,930,731 in FY 2015, down 2.2%.

The fines category is the largest with \$113,579,133 collected during FY 2015, accounting for 40.5% of the total limited jurisdiction court revenue. Most of these fines (\$75,521,894 or 66.5%) were assessed in municipal courts. Surcharges accounted for 27.0% of the total limited jurisdiction court revenue with \$75,716,183 collected during FY 2015. Combined fine and surcharge revenue decreased 4.0% from \$197,251,010 in FY 2014 to \$189,295,316 in FY 2015. An additional \$91,287,746 was collected during FY 2015 for court fees, fee revenue accounts for 32.5% of the total limited jurisdiction court revenue. The majority of fee revenue is collected by the municipal courts (\$53,110,299 or 58.2%).

Maricopa and Pima County Justice Courts comprise 55.7% of all justice court revenue. Municipal courts from these two counties constitute 84.9% of all municipal court revenue. The two largest municipal courts--Phoenix and Tucson--not only account for 36.6% of all municipal court revenue, but 23.2% of the revenue from all Arizona limited jurisdiction courts.

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$26,057,240 in "pass-through" trust monies during FY 2015, most of which were for bail bonds.

Some of the FY 2014 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
