## ORDER

The Commission on Judicial Conduct reviewed a self-reported incident involving two judges and found no wrongdoing on the part of either one. The Code of Judicial Conduct does not allow judges to solicit contributions for charitable or other similar organizations, and, knowing this, the judges in this instance had taken steps to avoid any problems in the organization to which they belonged. Unfortunately, newly installed officers were not aware of their instructions and inadvertently allowed the judges' names and titles to remain on the organization's solicitation letter. Upon learning of the error, the judges immediately corrected the situation and notified the commission.

The complaint is dismissed pursuant to Rule 16(a).

Re: Self-Report of Solicitation Letter on Letterhead Involving Judges

Dear Judge Brammer and Honorable Members:

We write to self-report the inadvertent use of our names and positions on a recent solicitation letter by a charitable board on which we both serve, along with our prior preventative and curative efforts.

We serve on the board of the \_\_\_\_\_\_\_ an Arizona non-profit corporation which is tax-exempt pursuant to Section 501(c)(3) of the Internal Revenue Service Code. The organization held a fund-raiser on \_\_\_\_\_\_\_ on behalf of its annual needs. Our newly installed president and interim executive director sent out the attached solicitation letter, which included in the letterhead each of our respective names ("Honorable....) and positions \_\_\_\_\_\_\_ As you can see, our names appear in the listing of the twenty-five board members. The listing of the board of directors is printed automatically by the computer as part of the letterhead.

Canon 4C(4)(b) states clearly that a judge may not be listed as an "officer, director, or trustee" of an organization if the listing is "used for fund-raising purposes," the concern being, of course, that a judge is soliciting funds or allowing the use of prestige of a judicial office for fund-raising purposes. See Ariz. Op. 00-06 (2000) p. 9.<sup>1</sup>

A year or so prior to this letter, Judge had a conversation with the person in charge of sending out fund-raising letters and materials. He explained on our behalf that our names could not appear in any of those materials. In prior solicitations our names had been removed from the listing of board members. With respect to this letter, it appears, there was an oversight, where someone simply forgot to remove our names, as had been done in the past.

Once we learned in early February of the erroneous solicitation with the letterhead, we immediately raised the issue at the group's meeting on \_\_\_\_\_\_ The board approved a resolution removing from mention our names or positions on the board's letterhead. This was done to eliminate the possibility of an incorrect letterhead being used in future fundraising efforts. We also had our names and positions removed from the listing of the board in the group's newsletter.

Beyond that, on Judge by phone notified Keith Stotts, your executive director. Mr. Stotts advised that this self-report/resolution letter should be sufficient to resolve this matter. However, should there be a need for any additional inquiry or action, please do not hesitate to contact either of us.
