On or about 7:30am, on I was awakened by our dogs going nuts, barking and jumping up and down. I have been housing dogs and cats, because the was kicked out into the cold by Police Chief and the Police department. I could not see these baby puppies and kittens put out into the street. I also have three service dogs and several cats (that have all been spayed and neutered). I was running to the front of the house to look out my front window, to see who was there so early in the morning. As I went to the window I saw a large man prying my window and reaching into my home. He was surprised to see me. He stepped back and showed me the gun he had stuck into the waist band of his pants and said, "The cops are not going to anything to me I work for a judge BITCH and now you will get yours".
I turned and ran down the hall to the back bedroom, to wake up is a vetern and is on heavy medication. I had a lot of trouble, trying to wake him up. Finally he got out of bed and pulled on his pants. He had to go to the toilet and then he was going to call the police. He opened the bedroom door to go to the telephone and was pushed back by tremendous heat and he saw flames. Our big guard dog, was singed and pushed his way into the bedroom.
said from what he could see, that the swamp cooler had crashed and blocked the back outside door and that the front outside door was nothing but flames. We could not leave by the bathroom window, it is only 3ft by 1ft. was in a daze. I shook him and screamed for him to break the back window in the bed room. He still didn't move.
" I SAID BREAK THE WINDOW, DO IT NOW" and I pushed him toward the window.
I let the baby kittens out of the bathroom and started looking around for the dogs. I wet a big towel and ran to the window. I could not breathe.   I was on no mediation. I tried to grab the dogs, but pulled me out of the window. I discovered later, that my personal dogs and my 2 old personal cats, did not make it out of the fire.
Here we were standing in the back yard and we had no way to get over the 8ft wood fence.
The contractor that was working on the Judge's property made us remove it. So we were just standing here yelling for help. Four of the neighborhood teens came to our rescue and by sheer strength pulled our fence down and got us out of the back yard.
At that time, I blacked out and only heard a lot of people talking around me. I heard someone say it was only 8:20am. And, our neighbor asked this man taking pictures, "What are you doing?". He was already there, before the fire engine and the ambulance got there, like he was waiting for it to happen.
The Fire Chief had third degree burns and the rest badly burned fingers, trying to save one of our puppies. The dog and his

the only animal to survive the fire.
the home renter, was in the hospital for two days. On the day of her discharge her and a friend saw the man who started her fire, ride by the hospital on his motorcycle. He has been seen around any and all parts of the area she is hiding out.
He is still armed and he is still stalking her.
has had a restraint order against this man, that is good for one year.  He has broken this restraint order more than one time and has never been arrested for violating this restraint order? Because he works for a Magistrate Judge?
