I lived with [Redacted] In [Redacted] for six months, Until I moved to [Redacted] I hadn't seen [Redacted] since [Redacted] Until hearing [Redacted] [Redacted] has had 2 Protection Orders Filed against Me. 1st [Redacted] The 1st P.O. served without a copy of petition (Copy#1) 2nd [Redacted] filed [Redacted] served [Redacted] (Copy#2) Both P.O.s were filed in the [Redacted] Justice Court., By Judge [Redacted] [Redacted] now lives in [Redacted]

.I feel judge [Redacted] lied about receiving the blue paper. [Redacted] A protective order, whether or not registered, is a valid order of the court for a period of one year from date of service.(IN [Redacted] PETITION, SHE KNEW THE DATE PO EXPIRED) (Copy#2)

I feel judge [Redacted] knows, [Redacted] dos not live in his jurisdiction.

I was not informed in court or out, I could appeal Judge [Redacted] decision..After researching the Web, .I contacted [Redacted] Superior court, Asking to appeal a P.O. after a hearing, I was informed that, [Redacted] Justice Court, Had to send transcripts of the case..I faxed [Redacted] Justice Court (Judge [Redacted] for appeal papers(Copy#6) [Redacted] I was informed by letter [Redacted] That the 15 day limit for appeal had run out.
