Every time he would write to the court it was a lie. I in turn wrote back with the truth. I have [redacted] that are [redacted] yrs old. [redacted] has been grooming my daughter for a long time, and [redacted] would tell me a few things that goes on at Daddy's house and with his friend [redacted] I did not know all the facts at that time. I got a protection for myself because of the threats [redacted] made to me, on the phone (harassing phone calls, and for my children, because of some of the facts [redacted] told me, this was in [redacted] IN [redacted] we went to court and the protection order was dismissed. I asked the judge to please have someone talk to my children she stated No they are too young, but if they go to a counsellor she would honor that. In [redacted] I called cps to talk to the children, but at that the children would not say anything about what happens at Dads. [redacted] was brain washed by Daddy, would not talk about daddy and [redacted] was too scared. The weekend of [redacted] the children were with their father, oh [redacted] told me everything about Daddy. So I had

[] repeat what he just told me and I taped it, I called [] Sheriff and they took the tape also brought a tape to [] police, started the children in counselling at [] [] has started tell about Daddy now and they both are telling facts about [] which I didn't know before, [] told me that they couldn't say anything before cause Daddy said not to tell anyone what happens at his house or he will go to jail, [] was in jail ~~in~~ for Substance abuse and Domestic Violence, and the children were aware of this, also the judge was aware of this. After I gave the Sheriff the tape of what [] told me, The Sheriff said to go get a emergency protection order for me and the children which I did the judge did honor that,

ON [] we went to court, [] presented Perjury again, I brought the tape to court but for got a casset recorder, I

thought the court would have one, the court reporter went to find one but there wasn't any available. The Judge said we don't have to listen to it, since it's just you and your son. The Judge had the police report from [redacted] the Sheriff report, my tape, was brought in to court [redacted]. The other reports she had way before [redacted]. The report of [redacted] was brought in on [redacted]. The Judge did not consider any of the evidence even asked [redacted] if he needed supervised visitation, and [redacted] said No. So she granted it. My husband told the Judge, that it is my way of keeping the children from him, which is not true, I think sexual abuse is a good reason. I guess the Judge thinks it's OK. The Judge told me in court that I had to give the children to him that day of court. That guy named [redacted] was also in court that day. The children were

upset when I told them they had to go with their dad, they didn't want to go. [redacted] told me that Daddy was playing with her private parts again. She said she told Daddy No but he did it anyway using tongue and finger, and [redacted] watched. [redacted] also told me long before court about the [redacted] that Daddy put his finger in her and she was bleeding. [redacted] said that [redacted] was cry. [redacted] also watched this. I want [redacted] to get checked at [redacted] and the judge denied it, I have called CPS again. The judge dropped child support from \$ [redacted] a month to \$ [redacted] a month. I have [redacted]
She is making me pay for the Divorce I thought it should be divided.

I think [redacted] is a terrible Judge. I think she should be Fired, immediately.

She told me in court that if I didn't turn the children over to

their Dad immediately she would give him full custody, and if he had any trouble from me she would be at the court house the rest of the day,

I am only trying to protect my children. I am not sure what's going on with Daddy, [redacted] all I know right now is the touching of [redacted] private part, and the observing of sex acts and Daddy hurting [redacted]

Since there is a ongoing investigation you would think a decent Judge would care about the children. Thanks to her the children are being molested every other weekend. One would think she would not have giving [redacted] joint custody. I want [redacted] checked at [redacted] like I said before she should be fired.
