harassment to "STALKING." Judge [redacted] ADVISED me that
she would set my petition for a "Hearing before Order," AND
ADVISED ME TO go IMMEDIATELY TO THE [redacted] POLICE DEPT.
AND file a report for "CRIMINAL STALKING," which I did, and
THE [redacted] POLICE REFUSED TO TAKE THE REPORT. A HEARING
on my petition was held [redacted] AT 11:00 AM, IN THE
[redacted] JUSTICE COURT. [redacted] PRESIDING.
During this hearing THE DEFENDANT'S OPENLY THREATENED ME
AND GAVE ULTIMATUMS TO THE JUDGE. STILL THE JUDGE MADE
NO DECISION ON MY PETITION. SINCE THE HEARING OF
[redacted] THE DEFENDANTS HAVE BEEN GIVEN PERMISSION
TO SITUATE AN RV OUTSIDE OF MY RESIDENCE IN A
LOCATION THAT makes it possible for DEFENDANTS TO LOOK
INTO MY HOUSE. [redacted] I CALLED THE COURT TO
INQUIRE ABOUT THE STATUS of my petition. I WAS TOLD
NOTHING. [redacted] AT 3:00pm, I WENT TO THE
JUSTICE COURT AND REQUESTED TO SPEAK TO THE JUDGE. I
WAS REFUSED AN AUDIENCE WITH THE JUDGE AND GIVEN
NO ANSWER REGARDING MY PETITION, RATHER, SENT AWAY.
THIS JUDGE HAS KNOWINGLY PLACED ME IN PHYSICAL
DANGER BY DELAYING A DECISION THAT COULD POSSIBLY
PREVENT PHYSICAL HARM TO MYSELF.
IT HAS BEEN [redacted] DAYS SINCE THE HEARING AND STILL NO
decision. WITNESS TESTIMONY WAS NOT PERMITTED!
