So I signed the plea. At my sentence the judge (Ronald S. Reinstein) gave me 8 1/2 years for a gun-box. I Fainted right there, literally! In front of my Dad & mom. (Ronald S. Reinstein) aggravated my sentence and made it dangerous, because I asked my probation officer why he was wearing a bullet proof vest, literally! No jury.
