back. The original deputy came back and claimed that I was lying. My wife told me
later that she explained to him that we were on a business trip. The original deputy
claimed that I was using the vehicle for pleasure. He wanted proof that I owned the RV
and that if I could not prove it he would seize it. I said that I didn't have to prove it, that I
knew the law and he was wrong. That if he thinks I was wrong then go ahead and arrest me. He said that pursuant to A.R.S. section 28-4532 (B) that it was unlawful for me to
drive the vehicle with a dealer plate on it for pleasure and said that he would have to seize
the plate. I tried to point out to him that he was incorrect again but he insisted. Rather
