COMPLAINT AGAINST A JUDGE

Dear Sir(s) I can't be sure of the date that all of this started it has been going on for quite			
some time.			
I have had a view deck over my patio for approx 4 years. I had this deck built when my			
pool was put in by pools.			
In I began to build a fence in my front yard to separate us from our neighbor			
whom we have had problems with for the last 7 years. The man is a			
peeper, we have pictures of him video taping into our backyard we have made police			
reports but apparently this is not illegal. This is not the only issue with our neighbor. As			
the fence became more complete from the city office came around and			
then decided that my deck was illegal as she states that she saw it from the street upon			
driving by. No she was in our neighbor's back yard. It was then that she decided that it			
needed to come down along with the wall. I went to the city office to get a copy of my			
pool permit and plans to show that this was to be done at the time of the pool, but			
conveniently our plans have been destroyed. So the burden of proof lays on me. I have no			
proof my plans were destroyed.			
Other than the contract that I singed and Judgefelt that this was not good enough.			
I have since been to court at least 10-15 times over all of this. At one point I went into			
court on and Judge was not present, it wasn't until late			
that I was told he would not be in. It was myself the court reporter,			
and the our neighbors that we are in dispute with, my question			
is why were they their?. When I was told that would not be in I was upset I was			
attending a family funeral in California so I had to leave to appear at this hearing. On the			
Friday prior to the hearing on Monday the I called the court house to see if in fact I			
was to appear due to it being I was told yes it would be court as			
usual. So after I heard that would not be appearing I blurted out this is bullshi I			
immediately apologized and then I was held in contempt and ordered anger management			
classes. I fill that for whatever reasons the Serve and protect officials of find any			
way they can to harass me. On this same day as I left court room and man in plane cloths			
whom was in the court room approached me from behind grabbed me by the arm and said			
don't you go any where and started yelling and rambling at me. I have seen a Dr. for my			
arm and had an MRI due to the pain and it is ongoing. I field a complaint at the police

department with and Officer on complaint when I
field the complaint I describe the man at this time I was told who he was. When I field
the complaint I was asked are you sure you want to do this is an officer
who has been to my home several times due to the ongoing harassment of my neighbor,
even though they are peepers, go threw our trash and call in false 911 police reports,
threw the judicial system it would seem that I am the one doing the harassing.
Each time that I appear in court I am fined and threatened with jail. If I question any
thing said I am threatened with jail. My last appearance was I believe
about the deck, my engineer was present because he was ordered by the court. He was
told that he had 7 days to draw up my deck so that I may obtain a permit. He said he
could not do this in 7 days he was given no other choice. I then went to the city office and
asked again about a permit before proofs and was told their could be no permit with out
knowledge of what they were permitting. I then went home and tore down my deck and
submitted proof to the court. I have also taken down the fence in question these things I
have been fined for and threatened jail time.
My neighbor's wall is maybe 2 feet high on his side on the driveway; from here you can
look right into our backyard and pool. I put a wood plank up on my pool gate to keep
some privacy while we are in our pool and to keep the neighbors grandkids form hanging
over the fence into our yard. It was not permanent it does detach. My neighbor was
having some work done in his back yard, when I went to court regarding this and was
also fined and threatened jail time. I toldit was only temporary and the purpose
was for privacy as the workers walk to the back yard and park in the driveway they can
look right into our pool. I was orderd to take this down and I did at the time of my
hearing I told again it is temporary and when they were done it would come
down, came by the day of another hearing and said it was not down. She
has never once knocked on my door and questioned any thing for which she and the court
are harassing me about.
I have also been fined for parking my boat and truck in my driveway that protruded on
the white line I had a cone on the line to let passers by know that it was a close drive. My
neighbor called the police not one officer but 2 and a commander appeared, odd.
We had company arrive and I was just getting ready to head to the gas station when the
police arrived I was not allowed to move the vehicle until the commander arrived they
were abrasive and rude at this time the commander moved the cone out into the street
then took a photo. I was given a ticket when I went to court I had to appear before
and with no surprise fined.
These are just a few things I could go on, but I think you may get the understanding of
what is going on.
