He has even went to instruct her to take child support, when she came into court, saying that she didn't want child support, just equal joint custody of the two children. He has told me that, he wouldn't allow every six months, and I'm supposed to have a one day mid-week visit, along with the weekend visit. Judge

once again, has denied me of the one day mid-week visit, because I don't get a set off day, and this up coming hearing, that's schedule for

he stated that I have to show proof of burden, for what we are supposed to have joint custody of the children, every other week, but because I can't find a sitter for the children at night. I feel that I'm being punish, while the respondent, who doesn't have no one to watch them, while she work in the day, except for paying for day care, which I pay, by my child support, which has gone up from \$144.25 to \$798. And some cents. Judge

has shown me, that he favor the respondent, and he discriminate against me, who he keep saying that, it is in the best interest of the two children. Well, I have a 2200 sq. ft. home, with four bedrooms and two baths. My children have there own bedroom, at their mother, they share a two bedroom apartment, where

sleep with her two brother, in the same room. Judge knows that the best place for the children, is with their father, but he continue to favor the mother. I even tried to have him removed from the case, but he denied that also. He has yelled at me, not to tell him what words to use in his court. I would like some one else to handle this case, what happen to the judge who was on the case before judge
