I was given your name to contact to report the questionable conduct of one the Superior Court Judges-in this case. I am the Plantiff on the defense had ignored myself & this court case until I had to file for default in . The defendant finally hired an attorney here in Arizona at this point & the attorney in turn filed a motion to have the case dismissed because the defendant is not an Arizona resident. I was/and am prepared to re-file the case in court, but an Oral Argument hearing was set for in front of . She stated that it should have been sent to an Commissioner but was in front of her instead? seemed very patient & polite to me, had me begin with an opening statement on what the case was about & when she interrupted me to ask the defense council a question, she even apologized. But I was never allowed to continue with my opening statement. The defense council did agree to pay for mediationthank goodness finally since we're finally going to discuss & work this out! However then the defense council told Judge about a letter I supposenly wrote to an auction winner but he filled it full of lies. The Judge immediately placed an Gag order on myself, without even asking me anything! When I asked to speak, I was not permitted to present any evidence. The Judge wouldn't have the attorney show this letter that he was accusing me of. And I got upset, I openly admit this. Years back I had a partial stroke after testifying in a court. My health is extremely poor, I don't know how much longer I have it's that severe. I am also classified as totally disabled. When I asked Judge why I was being punished with this restraining order, she replied that it wasn't a restraining order YET-at which point she nodded to the defense attorney who was allowed to leave the courtroom before I was able to give him my contact info-that I was told to do so for the mediation. It appears to me that the Judge was acting partial to the defense council because of the facts of myself not being an attorney, not knowing the exact rules of procedures & my physical health which I can not help. But I do know that the Judge is NOT to show partiality! As I stated previously Sir,I am about to refile in court and with this Gag order in place I can not procede to gather evidence. I have already sent in a motion to Judge about this, but have heard nothing. I also, trying to show that I do not have any mental health issues, have already seen an therapist thru my health insurance which did an intake and made an appointment for myself with a phychatrist for .To try to show the Judge & defense that I am not "nuts" nor an endangerment to anyone. I wrote a two page letter to Judge about what occured at the Oral Argument Hearingincluding about my voluntarily visiting these mental health specialist, but again have heard nothing. When my mother tried phoning Judge office to try to explain about my health, they wouldn't even take her phone number-which I can understand since she is not the Plantiff, but I left phone message with my return number and did not hear back! I am the Plantiff in this case Sir & deserve the same respect as any other Plantiff. I am very concerned what Judge is going to allow or have the defense council do next.
