I filed a continuance <sup>(upon getting a letter from help me! that she could not further)</sup>  
I called Judge Buttrick's secretary to see if he had reviewed it. She informed me that he had but do to the time ~~for me~~ I would still have to show up because even if they had sent ~~out~~ mail they couldn't notify the other party + party's attorney in time. I was under the impression I was getting it granted. Especially since 1 out of 5 motions had been answered that were all filed on the same day. I was in fear of not having counsel represent me due to the fact I had went to Special Investigations in the case which ended in a raid that I had committed suicide on. I was blamed by his parents and my life threatened. <sup>had committed</sup> <sup>served me</sup>  
17 days before my court date of <sup>(the same day as his suicide - <sup>with</sup> some hours of therapy)</sup> the judge not only declined my motion he didn't even have knowledge of my motions that stamped from downstairs. I gave him copies. 1 of them was to keep ~~them~~ return the same Judge that had started I was to clarify the false reported documents that started the case that I lost custody because of <sup>the</sup> to clarify stated that <sup>had temporarily</sup> I revoked all rights "but" <sup>for 14 or</sup> it was never cleared up and he was aware and said he didn't feel it would do any good. I have never had a bad test, I never have been in any raids (they said so many untrue, reported by changing 3 attorneys, 2 judges) I had 12 detectives appear in the case because <sup>had</sup>

of the fact he had money + knowledge of the law and could manipulate it. They have done the same thing and she is very pleased. I was in fear of my life being in court (unrepresented) and I told the judge I couldn't continue. He said it would not matter. I was in fear of what I might say would harm me. It didn't matter. Not anything they represented or entered is true and I have cross-referenced it to police incidents where I went for help/assistance to get my child + ~~he~~ went to court underhanded. I could have corrected everything. But it didn't mean a thing to judge. Tell me how clear and convincing is using knowledge of the law and having money to take someone's child and ruin their life?

I was never even present in the hearing nor did I know about it. I had found out that I had went to Special Crimes Det. and underhandedly done the whole thing. She filed after he died and my attorney I had retained told me it was dismissed (he died) (he filed) + I were in complete agreement and all at the sudden she held my son from me, moved to a new address + went into court when she got her rights restored from criminal charges. I have never had any bad tests or bad doctors. I can't believe this.
