This reign of misconduct and abusiveness by this judge started
hearings all together. Attached are copies reported by my doctors and dates, along with my income tax statements to help you further understand my complaint.

First of all,my son's mother, was not even held accountable by judge ,for any financial responsibility in this matter, which I found to be decidedly inconvenient and morally wrong seeing as how I paid her child support for a number of years before my son was taken away from her for child abuse, who now resides with his legal guardians,

I contest the legality of decision on this.

When I questioned this, stated in anger, "Your'e not here to ask questions or voice your opinions", in essence telling me I had no right to defend myself on the witness stand. I consider this abusive misconduct on her part. I also question her "funny math" in ordering me to pay \$553.00 per month, based on what little income I have. (Income tax statements attached) Even though my mother legally gifts me per year, this in no way coinsides with her determining I make per month. Even with the gift, is about \$1,000 a month off of reality.

To make matters even worse, Nygaard didn't even give me credit for approximately \$5500.00 I gave to help my son's guardians between which I only did out of generosity simply because I didn't do it through the child support clearing house, which I now do. Because of this and my son's mother not having any financial responsibility, I can no longer afford to pay for my own health insurance, at age 55, which could care less about, as I can only work part time due to hypertensive heart disease. (Please see attachments enclosed from my doctors.)

I can promise and The State of Arizona a large lawsuit if my health deteoriates further because of not being able to afford health insurance and my medications due to her ruling. The inmates in the Arizona State Prisons receive better medical care than I do. Who died and left God?

More misconduct and abusiveness: His name escapes me, but the prosecuting attorney who questioned my health condition was allowed by to twist and contort my inability to work full time, therefore, letting an eager attorney who probably wants to make a name for himself play "Doctor" with me and contest the competency of a Cardiologist and Surgeon. When my attorney and I objected to this underhanded line of questioning, again yelled at me and stated "Your'e not here to give your opinions".

I have always lived within the law, but never in my life have I ever been made to feel like a criminal when I have done nothing wrong as I felt in supposed disgraceful court of law, if you want to call it that. Lastly and most importantly it scares me to think about abusive judges like her to continue like this without being censored or removed from office.
