This error has been pointed out to both Courts, and as suggested by the Court, photocopies of my identification cards, a valid Driver's License and Active Duty Military Identification, have been provided. My request and copies of my identification were filed and accepted by the Court in correcting the Court error regarding case

In as such, I view the Courts inaction to follow through on my request to remove my name and address from their common data base as unprofessional and a failure in the performance of their duties. In addition, I feel the Court's lack of attention and unwillingness to communicate with the Court to resolve this matter is also unprofessional and indicates a failure to perform their duties in an ethical manner.

My attempt in resolving this matter has been unsuccessful. I previously requested the Court and Court provide me written responses stating that my name and address have not been associated with any delinquent obligation reports and that my name and address had been removed from any other Court data system in

Additionally, I am requesting that the Commission provide me information regarding the original source which associated my name and address in cases involving in hopes of ending the association.

I have great concern with the Court and Court letters which stated "possible sanctions, which include actions by a collection agency, the interception of your Arizona tax refunds or lottery winnings, and other sanctions authorized by law" and the Court letter letter which "ORDERED" that I provide a copy of my current driver's license. I view these statements with great regard since they could affect my security clearance with the U.S. Navy, credit profile, credit rating and possible lead to additional costs to myself and my family.
