I had a restraining order placed on The mother of my children has a long history of abuse and harassment against me and my wife. Some, but not all, of The complaints filed with The police are

To make a long story short I had allowed my oldest son who was 13, to molest my daughter who was 5. Because of her inability to parent and because I could not be released from The Juvenile Detention Center if he had contact with his siblings, I took custody of The other six children. I was trying to block counseling of and did not want me to cooperate with The County Attorney against her. She started doing The same things she has always done. When I came to court I brought all The police reports, The restraining order, and The restraining order I had in place at That time.

When I go to present The evidence I had, Judge was very rude. He said That was old and had nothing to do with today's hearing. I told Judge It shows a pattern of harassment, Judge started talking down to me and said I wanted him to decide custody. I told Judge That was not true, I wanted to protect

my daughter who had been  
 molested and was bringing  
 to the house. Judge did not  
 care at all. I was livid. I had  
 proof of things had done and  
 Judge didn't care and refused  
 to read my proof. I asked Judge  
 how long was going to  
 be allowed to get away with this  
 behavior. Judge said what I  
 believe to be unforgivable. He told  
 me "Do you want me to get you a  
 soapbox?" I was past outraged. I  
 called him a "fucking punk" several  
 times. was sitting there smiling  
 the whole time. I went to take my  
 paperwork off his desk and he grabbed  
 it and held it behind his back. Judge  
 told me "I can hold you in  
 contempt" and I responded "You are  
 responsible if anything happens to my  
 daughter!" He thrust my paperwork to  
 me and I left.

In closing it is a shame as  
 a 35 year old black man that I  
 have to constantly be judged by  
 old white men who have no respect  
 for me or my race. Judge  
 is representative of the disrespect I  
 have received in my life from a system  
 that is 99.9% white and upper-middle class.  
 He had no respect for me and

showed no class or integrity. I became vulgar with him when it was obvious that he wasn't listening to me and had no intention of protecting my daughter.

Judge \_\_\_\_\_ is a disgrace and has no business making decisions that affect people's lives.

I hope that at the very least he will be reprimanded for his behavior.
