ORDER

The commission reviewed the complaint filed in this matter, as well as the recording of the proceedings, and found no ethical misconduct on the part of the judge. In arriving at this decision, the commission noted that the judge did not state or testify at any time that he observed the fight in the parking lot. Criminal speeding charges cannot be dismissed in exchange for attending defensive driving school, and another judge handled the traffic case.

The complaint is dismissed pursuant to Rules 16(a) and 23.

Attention Commission on Judicial Conduct

My complaint is against Judge [redacted] but
My goal here is not to harm Judge [redacted] but
to clear my name and to right a wrong that has been done against me.

My experience in Judge [redacted] court began with a small claims filed against me by
a tenant of [redacted] was forced out of the home
per [redacted] request. I collected \$5600 hundred dollars from [redacted] all
of the money was accounted for. \$4200.00 dollars went to [redacted]
\$268 was refunded back to [redacted] and the difference was paid to
water and [redacted] electric. I did not profit a penny of the money nor did I embezzle
any money all proof was provided in court. Yet Judge [redacted] ruled that I give
over \$900.00 dollars with no explanation as to why I would have to repay money that I
did not keep. I accepted that ruling and upon leaving Court I ask [redacted] had he
lied to the Judge about something while I was not present. I also asked
would he like copies of the canceled checks that he and his daughter had cashed. At no
time did I yell or swear

While standing out side talking to [redacted] started yelling at me
across the parking lot. [redacted] was saying shut up stop talking to my husband.
She then started pushing up the sleeves to her shirt and started saying I want that bitch. I
am going to get that bitch. [redacted] starting coming at me and lunged at me. I
pushed her in the face to keep her off me. [redacted] sister then grabbed me and
held me while [redacted] continued swinging at me yelling and cursing.
[redacted] was running around the parking lot cursing and yelling till her husband was
able to restrain her and drag her to the ground. At no time did I curse at
she was the aggressor. When the altercation started Judge [redacted] was still in the
court room. I saw him when he came out. Judge [redacted] went over and started talking to
[redacted] asking her what had happened. She was pointing over at me. I don't
know what was said but what I do know for a fact is that Judge [redacted] did not see
what happened at the begin of the altercation. In the police report Judge [redacted] states and
argument started outside and he responded out. This clearly proves Judge [redacted] was not
present when the altercation took place. When Judge [redacted] came out he stated that he
ordered people to cease and desist. But the truth is by the time Judge [redacted] had come out
of the court room I was sitting in my car crying. The information he got came from
[redacted] There for how was he able to testify as to what happened or who started
the altercation. There was how ever a witness who clearly heard [redacted] calling
me a bitch and she provided a statement to the police. See copy enclosed.

A few weeks later I received an order of protection that Judge [redacted] granted against me. I appealed it and requested a hearing. Present that day was myself and Judge [redacted]. On that day I asked why a restraining order was given against me when I have never threatened or harassed Judge [redacted]. Judge [redacted] said to me that calling some one a liar is threatening them. The word Liar means. A person who tells lies. The word Lie means a false statement made with the intentions of deceiving. [redacted] not only are liars but that broke the law. [redacted] testified on that day that no one used profanity. Yet I told the Judge that threaten me with profanity. Not only did a witness see and hear using profanity but the court clerks also heard all the profanity being used. If I were the one using the profanity I am sure [redacted] would have been more honest. [redacted] also lied about the purchases of their homes. They along with several others committed fraud and purchased a lot of homes owner occupied took all the equity out of them continued collecting rent only to let the houses foreclose and people end up homeless. I provided Judge [redacted] court with that proof as well yet during a civil hearing I was order to pay [redacted] money that I did not collect. [redacted] admitted in open court that she was not making the mortgage payment not to mention the tenants had moved out. I did not collect rent for Nov and Dec. So why was I order to pay a debt that I did not owe? How is it that people who break the law a person who comes forward and has proof of wrong doing continues to get punished.

I was found guilty of disorderly conduct. One because I was late for the hearing. When I spoke with the prosecutor from the state he said his strongest witness was Judge [redacted]. That to me is truly disturbing because again if Judge [redacted] was not present to see who the aggressor was what could he have possible said. The charges against [redacted] dismissed. The police could have only testified to what the witness statements said. When I read those statements they support more of what I having been saying all along. If you request the recordings from the order of protection hearing you will clearly see that [redacted] claims that no profanity was used by either party and you will clearly hear me stating [redacted] was threatening me and when she lunged at me I merely protected my self. You will also be able to hear that at no time have I ever threaten [redacted] in any way. In fact [redacted] is the one who came by my home and threaten me. The court clerks heard the profanity and so did the witness. The order to pay [redacted] money on foreclosed homes that they bought through fraud is also wrong. I truly feel that Judge [redacted] heard a group of dishonest people say things about me and formed an opinion of me based on lies. Those people are trying their best to cover up a real estate scam that they committed. I wrote the Governor of Arizona, Attorney Generals office, the banking commission, the newspaper, and wrote the board of realtors. I hope the crime the [redacted] and others like them committed doesn't go unpunished. Judge [redacted] may feel it was ok what they did but I know it was wrong and the families that have suffered because of it know it was wrong. I was never treated fairly after that. I have never at anytime been rude to Judge [redacted]. Never disrespected him only did my best to understand how he could continue to close his eyes on the wrong doing of others. Try and understand despite all the proof I provided to him that I had done nothing wrong I was continued to be hurt and punished. At the resent civil hearing.
