I would like to have this case moved to another court because I do not feel I'm getting a fair trial with the present judge. Due to the fact that the plaintiff's Atty. _____ was the City Attorney for Bullhead City, Az. for many years, I feel the judge leans in his favor. The plaintiff has told her Atty. many lies which have been presented in this case. At the pretrial the plaintiff was not present, just her Atty., and I was not allowed to present my case. My dad wrote a letter for me stating my side of the case and the judge would not ever look at it, and would not let me speak to defend myself. I was told later the judge had already ruled on this case, and I was not even there because I didn't know about it, not getting a notice or anything. I cannot afford an Atty. I went to legal aid and was told they couldn't take my case because they were too backed up. Mr. _____ (the plaintiff's Atty.) sent me paperwork stating (1) I could not have a trial by jury (2) that the plaintiff would choose the Realtor (3) that I must pay her Atty. fees. I have lived in this house for 8 yrs. I am half owner. I have a deed to prove the house is in both our names with Right of Survivorship. The plaintiff and I lived together for many years in California. At that time I had a house in California. When we got together I rented my house out and went to live with her. She talked me into signing over my house to her, that she could get a lower interest and would sign it back to me at a later date, which she did not do. She collected rent for 8 yrs. has since sold it, and I did not receive a penny. I have been evicted ~~From~~ the house (that we own jointly) in Bullhead City, and not allowed to go back in and get my possessions.

Legal Aid told me that that was illegal, that they can't put me out of my house. I was told when they evicted me that I could call the Sheriff's Dept. and get permission to get my belongings. But when I called they told me they didn't know anything about it, that I should call the Police Dept. I went to the Police Dept. and they told me they knew nothing about it. I want it know that the Plaintiff is a multimillionaire and put the sale of my house through one of her Escrow Companies. This is all very unjust, and the judge won't let me tell my side of the story.

This is why I would like this case to go through another court with a different judge.
