I (Defendant) appeared at my pre-trial hearing and was **denied** the following:

1. To speak at all during the pre-trial even though the podium and microphone was designated for the defendant to speak and make petitions on behalf of oneself.
2. To relieve my court appointed attorney ( Private Attorney) for reasons of gross negligence and possible illegal/dishonest actions upon verbal request.
3. To relieve my court appointed attorney ( Private Attorney) (2<sup>nd</sup> time, same day, location and time) even after court appointed attorney ( Private Attorney) verbally stated to judge ( ) that he was in agreement with being relieved. The judge motioned to deny this relief for reasons not given upon request.
4. To verbally and /or physically submit a list of subpoena's in regards to witnesses in my case.
5. Dismissed from the courtroom without any status to which my lawyer is, how my case is to be handled or what I am required to do in detail. Neither my court appointed lawyer or the judge assisted me in anything at this pre-trial.
6. The prosecuting attorney (Ms. ) on the court house premises attended a case before my case and then failed to show up at my hearing having some substitute fill in.
7. Pre-trial was scheduled for 1400 yet at 1337 the doors were quickly shut to begin session (23 minutes ahead of schedule) without notifying myself or any of the other individuals present for their 1400 meeting. I was able to slip in and be present. My personal opinion was that I was being set up to miss the meeting so that I would be found guilty for non-appearance. I did assert myself and made it clear that I would not be pleading guilty to anything in regards to my case whatsoever.
