Kingman has its own tale of two cities. On one side, you have the Kingmanites known as Good Old Boys. They have the wealth that in turn buys power, law enforcement and political favors. Their justice and peace is bought and paid for to silence the witnesses and victims of their crimes.

Their crimes are silent and swept under the carpet by those sworn to uphold the laws. They hold us hostage and violate our rights because they know that "right" person that they can turn/go to, to call in a favor. Even law enforcement has become their close friend. On the other, you have the average citizen who works hard to support their family on wages that barely make ends meet. They don't have the luxury of having an attorney on retainer or extra money to put in someone's coffers. These people have gotten used to compromising their personal or professional ethics and have gotten used to turning the other cheek. They vote for change, but change only means more abuse of power. They openly complain that the Good Old Boys of Kingman will do whatever it is they want and wonder when it will all change.

I take this stand openly because in September I was raped by one of the Good Old Boys and my case was not prosecuted. My rapist is a known member of the community, step-father of a Sheriff's Deputy, a teacher who actively socializes with law enforcement officers including the investigative officer, my rapists good friend, and his supervisor. In speaking out about how the Kingman Police Department was treating me, they began treating me as a suspect instead of a victim. I was followed by on-duty Sheriff's officers; 11 miles one day. I had on-duty Sheriff patrol vehicles parked in front of my property for a few days. Another patrol vehicle parked in the lot next door that sat adjacent to my front door. I made a complaint, but my cry for help fell on deaf ears, even though there was only one K-9 unit on duty that last day.

As of today, I continued to be followed by Sheriff's deputies. The man that raped me has filed two false police reports against me for harassment. One police reports because some individual put posters up at the school with his picture on it, saying a sexual assault suspect works there. A second police report happened because my son's father and I went down to the district office to see what our options were since our son was to be attending the same school my rapist teaches at. The school district alleged we had caused a disturbance.

When I complained to the county prosecutors office, Victim Witness asked me who my attorney was. It made me stop and think, since when does a victim need an attorney? Let me tell you something, you will not find an attorney here in Kingman or Mohave County that will take your case to take a stand against the Good Old Boys.

I made a complaint to the Arizona Attorney Generals office and was sent a letter that said that if they were to hear from other individuals, they would re-examine my complaint; because by law their office cannot act solely on the behalf of one individual but they can on behalf of consumers as a whole. The truth is all the complaints and request for help that the AG's office has received have fallen on deaf eass. The Attorney Generals office is covering up the law enforcement and judicial abuse in Mohave County. Through my errands around the city, I have come across other men and women who began telling me their stories. Stories far worse than mine.

There is no agency to oversee the law enforcement abuse in this community. There is no agency to report police abuse, except to the police. The time has come for the law ensors of Kingman to stand up and say, NO MORE WILL WE BE INTIMIDATED BY THE GOOD OLD BOYS! NO LONGER WILL WE TOLERATE LAW ENFORCEMENT OFFICERS WHO ABUSE THEIR BADGE OF AUTHORITY. It is with hope that the true Kingmanites will come forward knowing that they no longer have to live in silence. They no longer have to be a victim. Their voices will finally be heard.
