They claimed, all the whilst "blushing" (were they feeling ashamed?) both girls that is with whom I had conversations, that nothing was showing yet and that they would find out, but for whatever reason they were unable to do so! This picture is one that Ms may still have and if it isn't in her possession or the Courts' either, then I will continue to suspect even more so that she did in fact lie and that she's protecting her lie and the court people may wish to protect her in her wrongdoings so as to justify what I consider "personally" legalized extortion from a poor person on SSI at 674/ month... I had no chance to explain the urgency of the moment in my needing to set an appointment up with as I'd been able to find this handicapped friend... This homeless friend is without a cell phone and very hard to get a hold of. When I spotted him there in the Fry's parking lot; I hurried over so as to not miss him before he would go into the store. I had other errands to do and had an appointment of my own for my discussing my financial needs with at the same church.

I am also a disabled person with a diagnosis of MS and as a result felt that it would be helpful that day to avoid the walking in a hurry which isn't always possible anyway...! (I'm also still and since the Month of June 2008 living out of my car, but anytime money allows I try to check into Motels so I can lie flat. Ford Focuses are not very roomy to sleep in...)

As I'd made an offer to move my car the which she refused to hear after <u>handing</u> me the ticket; she backed away from me in waving her <u>right hand</u> nd and her <u>head</u> nd at the same time meaning: don't talk to me!! It seems outrageous that as a person stands next to their car with such a worthy cause in mind as mine was for being there; I was not asked politely to move my car!! Whatever happened to good karma? Is it for real?! And don't you think Ms that if I had in fact been in the way of this woman's ability to load her disabled husband; she would have asked me to move my car as she was parked next to the curb to her left which would have prevented her ability to load him and his wheelchair from that side of the car!?

I know for a fact, as I was a nurse's aid for six months in 1993 ("when I was healthier") for a man named husband to Mrs. (Mrs. at the time) in that when a disabled person needs to be transferred from a toilet or a wheel chair to a different seating surface; space for this type of maneuver is needed and can't be accomplished easily if at all in a restricted area. The lack of room to make these transfers may even cause injuries if the party who is making the transfer is in the wrong position for the health of their spine. Certainly it couldn't have been done on top of the curb!! Nor could she have had an easy time in using a mechanical or hydraulic lifter for him to be transferred into the vehicle if she had to have

somehow gotten the "husband" on top of the rock bed. It still would have been done on top of an uneven terrain; that's not very steady!! Never did she ask for anything from me!! Therefore, I feel certain that Ms would have to be "lying".

I hope that you will see fit to push for some action to come about in regard to this wrongdoing on this Employee's part! Even if the ticket has been paid; I still believe it is important that those who are employed for city jobs or any job really do it with integrity so as to keep the reputation of their city (any city) in good standing before men and yes, before God as well!!

I do thank you for your time reading this long entry and would hope for a reply as to what will be done to undo this wrong or if an apology will be given in open court as I feel it should be admitted before the judge as well!! Obviously I do not doubt my judgment on this matter!!!
