The complainant alleged that the judge demonstrated bias against him by allowing the opposing party in a child support matter to lie about income, refusing to listen to tape-recorded conversations supporting his claims, and sending deputies to threaten and harass him. After reviewing the allegations, the judge's response, and the recording of the hearing, the commission found no evidence of misconduct on the part of the judge. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
