ORDER

The complainant filed two complaints alleging the judge assigned to hear his case should disqualify himself because of a conflict of interest. The commission investigated both complaints and found that the complainant's attorney had raised the same issue during a court hearing and that the judge had properly considered the matter and determined there was no conflict of interest. Accordingly, the commission found no ethical misconduct on the part of the judge and dismissed the complaints, pursuant to Rules 16(a) and 23.
