THE SUBJECT OF THIS MESSAGE IS TO DEMAND A PERMIT AN APPEAL CASE NO. CV08- i. THIS CASE WAS INTRODUCED AND HANDLED IN A POSSIBLY UNETHICAL MANNER FROM THE BEGINNING. AS A CITIZEN, I AM DEMANDING MY RIGHTS BE RECOGNIZED. THERE IS EVIDENCE, SOON TO BE ENTERED, IN ATTEMPT TO PROVE THAT THERE WAS DELIBERATE FRAUD, GIVING FALSE INFORMATIOM UNDER OATH, POSSIBLE BRIBERY, COLLUSION, ETC. ALL THE ADJECTIVES WHICH SUGGEST "DIRTY POOL". IN THE BEGINNING, MUCH CRITICAL EVIDENCE WAS THROWN OUT AND DENIED AS "HEARSAY". WHY? SHOULDN'T BOTH PARTIES BE PERMITTED TO PRESENT THEIR ARGUMENT? I WAS NOT PERMITTED TO DO SO. HERE IS EVIDENCE OF CLANDESTINE POLITICAL PERSUATION, DISTORTED AND INACCURATE. THIS WAS A REAL KANGAROO COURT.

I WAS MET IN THE FOYER OF THE COURTROOM, PRIOR TO THE HEARING, BY MEMBERS OF THE SEDONA CITY STAFF. AS SPOKESMAN. HIS VERBAL STATEMENT TO ME, WITNESSED BY MY TRANSPORTATION, WAS IN CLEAR ENGLISH "GLAD TO SEE THAT YOU MADE IT. WE JUST MET WITH THE JUDGE AND ARE READY FOR YOU". A LITTLE PREJICIAL? NOT BEFORE JUSTICE OF THE PEACE, THE HONORABLE

LIKE A CALF BEING LED TO THE SLAUGHTER, THE TRIAL BEGAN. I THEN WAS INFORMED THAT THE CRITICAL EVIDENCE, PREPARED BY A QUALIFIED AND LICENSED 3 RD PARTY, HAD BEEN DENIED, WITHOUT EXPLANATION, AS "HEARSAY" AT THIS POINT, MY WITNESS LEANED OVER AND STATED, "YOU HAVE LOST. THIS IS A REAL STACKED DECK AND KANGAROO COURT. YOU ARE DEAD IN THE WATER".

THIS HEARING BEGAN WITH PREJUDICE, INSENSITIVITY, COMPLETE DISREGARD FOR HUMAN DIGNITY. FOREMOST, I AM NOT ASKING FOR SYMPATHY. GOD FORBID. I AM ONLY SEEKING JUSTICE IN SOLOUTION TO A FLOOD PROBLEM CAUSED BY THE CITY'S IMPROPER MANAGEMENT OF STORM WATER. THIS PROBLEM WILL BE SOLVED WHEN A MULTIMILLION DOLLAR PROJECT IS COMPLETE. IN THE MEANTIME, PEOPLE SUCH AS REVEREND AND Ms ATTEMPTING TO EXPLOIT ME, A TOTALLY DISABLE VETERAN, 89 YEARS OLD AND MY 83 YEAR OLD CAREGIVER. I REQUIRE 24 HOUR CARE, APPROVED BY A DOCTOR. THE HONORABLE DENIES THIS, BASED ON NEIGHBORHOOD RUMORS.

I COULD HAVE SOLVED THIS JUDGEMENT 6 MONTHS AGO, BY ADMITTING GUIT TO SOMETHING I DID NOT DO. I SAID NO! I AM AND HAVE ALWAYS BEEN A MAN OF HIGH MORAL AND ETHICAL STANDARDS. I WILL NOT VIOLATE THIS AND CONRIBUTE TO WHAT I FEEL IS A PREMEDITATED SCAM, SINCE 1973. AS FOR THE REVEREND HE IS AN OPPORTUNIST WHO TOOK ADVANTAGE OF SOMEONE WHO HE THOUGHT WAS A "DEEP POCKETS". HE THRATENED TO SUE ME AND LATER GAVE FALSE WITNESS TO SUPPORT THE CITY OF SEDONA.

THERE IS MORE TO THIS STORY. I, SINCE I REFUSED TO GIVE MY CAREFULLY GARDED I. D., TO PREVENT I. D. THEFT, TO A PERSON WHOM, THROUGH MY THOROUGH MY CAREFUL RESEARCH, PROVED SUSPICIOUS. I WAS HELD AND STILL IN CONTEMPT OF COURT. THE IDIOT THAT I AM, I MADE A CHECK TO MEET HER DEMAND. I DESTROYED THE CHECK AFTER A BOYFRIEND, ACTING AS A COURIER, REFUSED TO GIVE ME A RECIPT. I THEN RECEIVED TELEPHONE CALL POTENTIAL VICTIM, A GUN DEALER WHO HAS A VAST CAPABILITIES OF CHARACTER REFERENCES. HIS SUGGESTIONT STATED THAT SHE HAS RECORD DATING BACK TO 1973. WOULD YOU GIVE HER YOUR I. D. INFORMATION? IF I AM ABLE TO PROSECUTE HER ON SCAM, THIS REALY WEALTHY WOMAN WILL REGRET SHE EVER MET THIS "DEEPPOCKETS" WHO IS A SUCKER FOR SAD STORIES, ESPECIALLY, FROM WHOM SHE BOUGHT THE PROPERTY, ANOTHER SAD STORY. ON A COLD AND RAINY NIGHT, FEB OF 03, CAME A KNOCK ON OUR DOOR. STANDING IN THE RAIN, SOBBING THAT SHE WAS OUT OF FUEL AND THE POWER WOULD BE SHUT OFF AT 10PM. I KNEW LITTLE ABOUT MY NEIGHBOR EXCEPT THAT SHE WAS IN NEED OF HELP. I INVITED HER IN AND CALLED BOTH THE GAS AND POWER. ON MY CREDIT CARD, BOTH SERVICES WERE RESTORED THAT NIGHT. I BOUGHT BOTH CATFOOD AND DOGFOOD FOR HER, WHICH I FOUND HER EATING. SAD BUT TRUE. THERE LOTS OF POOR PEOPLE IN SEDONA.
